Hydro One Networks Inc.

**Application for leave to upgrade a transmission line and associated
station facilities between Spruce Falls Junction and Carmichael Falls
Junction in the Kapuskasing area**

PROCEDURAL ORDER NO. 1

April 23, 2018

Hydro One Networks Inc. (Hydro One) has filed an application with the Ontario Energy Board (OEB) under sections 92 and 97 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B (Act) for approval to upgrade an existing 115 kilovolt electricity overhead transmission line and station facilities and of the form of land use agreements it offers to landowners to use their lands for construction of the proposed upgrade. The application was filed on February 6, 2018 and amended on March 8, 2018, to include a request for approval of the land use agreements.

The OEB issued a Notice of Hearing on March 27, 2018. In response to the Notice of Hearing, the Independent Electricity Operator (IESO) applied for intervenor status. No objection was received.

IESO is granted intervenor status. The list of parties in this proceeding is attached as Schedule A to this procedural order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and IESO shall request any information and material from Hydro One that is in addition to Hydro One's evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Hydro One by **May 8, 2018**.
2. Hydro One shall file with the OEB complete written responses to the interrogatories and deliver them to IESO by **May 23, 2018**.
3. Unless the OEB orders otherwise, any written submission by OEB staff and IESO shall be filed with the OEB and delivered to all other parties by **June 5, 2018**.
4. Unless the OEB orders otherwise, Hydro One may file a written reply submission with the OEB, and deliver it to the IESO by **June 12, 2018**.

All filings to the OEB must quote the file number, EB-2018-0098 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.oeb.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
