Applications for Gas Marketer and Electricity Retailer Licences (Agent Only)

The Applications

DeMark Home Ontario Inc. filed filed two applications on April 16, 2018 with the Ontario Energy Board (OEB) under section 50 and section 60 of the *Ontario Energy Board Act, 1998,* (the Act) for Gas Marketer and Electricity Retailer licences, respectively. The granting of these licences would enable the applicant to act as an agent or broker for a gas marketer, electricity retailer and/or consumer with respect to the sale or offering for sale of natural gas and electricity in Ontario. The granting of this licence would not enable the applicant to sell or offer to sell natural gas and electricity to a consumer in Ontario.

The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the Act. The OEB does not intend to provide for an award of costs when deciding the application.

Oral vs. Written Hearings

There are two types of OEB hearings – oral and written. The OEB intends to proceed with these applications by way of a written hearing. If you think an oral hearing is needed, you can write to the OEB to explain why. Your submission must be received by the OEB and copied to DeMark Home Ontario Inc. by **May 21, 2018.**

How to Participate

If you wish to participate in the written hearing, you may file a written submission setting out your views on the applications. Your submission must be received by the OEB and copied to DeMark Home Ontario Inc. by **May 25, 2018.**

If the applicant wishes to respond to the submission(s), such response must be filed with the OEB and copied to any party who made a submission by **June 1, 2018.**

All written submissions sent to the OEB will be placed on the public record, which means that the written submissions will be available for viewing at the OEB's offices and will be placed on the OEB's website. If the written submission is from a private citizen then, before placing the written submission on the public record, the OEB will remove any personal (i.e., not business) contact information from the written submission (e.g., the address, phone number, and e-mail address of the individual). However, the name of the individual and the content of the written submission will become part of the public record.

As stated elsewhere in this notice, you must provide a complete copy of your written submission (including your name, contact information, and everything written in the submission) to the applicant.

How to File Documents with the OEB

All written submissions filed with the OEB must quote file numbers **EB-2018-0110** and **EB-2018-0111** and clearly state the sender's name, postal address, telephone number and email address. You must forward two paper copies and, if possible, an electronic copy in Word format and in searchable PDF format, of your written submission to the OEB and one copy to the applicant. All written submissions should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
