The Ontario Energy Board (OEB) received NextEra Energy Canadian Operating Services, Inc., Sombra Solar, GP, ULC on behalf of Sombra Solar, LP and Moore Solar, GP, ULC on behalf of Moore Solar, LP's applications for electricity generation Licences amendments on May 8, 2018. The OEB has assigned file numbers EB-2018-0175, EB-2018-0176 and EB-2018-0177, respectively, to the applications. The applications will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the applications without holding a hearing.

If required, OEB staff will contact you directly to seek clarification regarding the applications and/or request additional information or material to complete the applications. For these purposes, OEB staff may contact you by email, regular mail, or by telephone. Once your applications are complete, the Delegated Authority expects to issue a final decision on your applications within 60 days.

In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your applications, you will be given an opportunity to provide comments. The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
