DECISION AND ORDER

GC Project Inc. on behalf of GC Project LP and Great Circle Power Corporation each filed an application on April 5, 2018, with the Ontario Energy Board (OEB), under section 74 of the *Ontario Energy Board Act, 1998* (OEB Act) to amend their electricity generation licences EG-2017-0099 and EG-2017-0100, respectively.

The OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act.

GC Project Inc., on behalf of GC Project LP has requested to amend Schedule 1 of its electricity generation licence EG-2017-0099 to add more generation facilities that it intends to own, as listed in Schedule A (Table 1), and to modify the generation capacity of some of its owned generation facilities under the authority of its licence as described in Schedule A (Table 2).

Great Circle Power Corporation has requested to amend Schedule 1 of its electricity generation licence EG-2017-0100 to add more generation facilities that it intends to operate, as listed in Schedule A (Table 1), and to modify the generation capacity of some of its operated generation facilities under the authority of its licence as described in Schedule A (Table 2).

This Decision and Order is being issued by the Delegated Authority, pursuant to Section 6 of the OEB Act.

The Delegated Authority has considered the application without holding a hearing pursuant to Section 6(4) of the OEB Act. The OEB finds that it is in the public interest to amend the licences.

IT IS ORDERED THAT:

1. GC Project Inc., on behalf of GC Project LP's electricity generation licence EG-2017-0099 is amended in accordance with the attached revised licence.

2. Great Circle Power Corporation's electricity generation licence EG-2017-0100 is amended in accordance with the attached revised licence
