DECISION AND ORDER

NextEra Energy Canadian Operating Services, Inc. (NECOSI), Sombra Solar, GP, ULC on behalf of Sombra Solar, LP (Sombra) and Moore Solar, GP, ULC on behalf of Moore Solar, LP (Moore) each filed an application on May 8, 2018, with the Ontario Energy Board (OEB), under section 74 of the *Ontario Energy Board Act, 1998* (OEB Act) to amend their electricity generation licences EG-2012-0311, EG-2011-0022 and EG-2011-0023, respectively.

The OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act.

Moore is the current owner and operator of St. Clair Solar 1 and St. Clair Solar 2 generation facilities under the authority of its electricity generation licence EG-2011-0023. Moore requested to amend Schedule 1 of its licence such that it will no longer be the operator of these generation facilities.

Sombra is the current owner and operator of St. Clair Solar 3 and St. Clair Solar 4 generation facilities under the authority of its electricity generation licence EG-2011-0022. Sombra requested to amend Schedule 1 of its licence such that it will no longer be the operator of these generation facilities.

NECOSI requested to amend Schedule 1 of its electricity generation licence EG-2012-0311 to become the operator of St. Clair Solar 1, St. Clair Solar 2, St. Clair Solar 3 and St. Clair Solar 4 generation facilities, as described in Schedule A, under the authority of its licence EG-2012-0311.

The applications have been considered without holding a hearing pursuant to section 6(4) of the OEB Act.

IT IS ORDERED THAT:

 NextEra Energy Canadian Operating Services, Inc.'s electricity generation licence EG-2012-0311 is amended in accordance with the attached revised licence.

- 2. Sombra Solar, GP, ULC on behalf of Sombra Solar, LP's electricity generation licence EG-2011-0022 is amended in accordance with the attached revised licence.
- 3. Moore Solar, GP, ULC on behalf of Moore Solar, LP's electricity generation licence EG-2011-0023 is amended in accordance with the attached revised licence.

DESCRIPTION OF ST. CLAIR SOLAR 1, 2, 3 & 4 GENERATION FACILITIES:

- 1. St. Clair Solar 1 with an installed capacity of 10 MW, located at Part of Lot 25, Concession 9, and part of Lot 26, Concession 9, Township of Moore, Ontario.
- 2. St. Clair Solar 2 with an installed capacity of 10 MW, located at Part of Lot 25, Concession 9, and part of Lot 26, Concession 9, Township of Moore, Ontario.
- 3. St. Clair Solar 3 with an installed capacity of 10 MW, located at North half of Lot 1, Concession 10, North half of Lot 1, Concession 11, West half of North half, Township of Sombra, Ontario.
- 4. St. Clair Solar 4 with an installed capacity of 10 MW, located at North half of Lot 1, Concession 10, North half of Lot 1, Concession 11, West half of North half, Township of Sombra, Ontario.
