- Expression of interest for general contractor services issued in August 2014;
- RFP for general contractor services issued in April 2016;
- Bids from general contractors seeking to build the EWT Line Project received in January 2017;
- NextBridge EWT Line Project construction cost estimate completed in support of the NextBridge Leave To Construct application in July 2017;
- General contractor selected and construction contract executed in December 2017.
