

Enbridge Gas Distribution Inc.

**Application for approval of the cost consequences of
the proposed Renewable Natural Gas Enabling Program
and Geothermal Energy Service Program**

**PROCEDURAL ORDER NO. 3
May 30, 2018**

Enbridge Gas Distribution Inc. (Enbridge Gas) filed an application with the Ontario Energy Board (OEB) seeking approval for the cost consequences of its proposed Renewable Natural Gas Enabling Program and Geothermal Energy Service Program. This includes approval of the methodology to set the service fees for each program and recording the annual sufficiency/deficiency of the programs within the Cap and Trade Compliance Obligation Variance Accounts.

The OEB issued Procedural Order No.2 on April 23, 2018, setting dates for interrogatories to Enbridge Gas. OEB staff and ten intervenors¹ filed written interrogatories with the OEB on May 2, 2018. Enbridge Gas filed written responses to the interrogatories on May 17, 2018. The OEB has determined that it will schedule a technical conference to address questions arising from the responses to interrogatories.

(Anwaatin), Canadian Biogas Association (CBA), Energy Probe Research Foundation (Energy Probe), Enwave Energy Corporation (Enwave), Federation of Rental-housing Providers of Ontario (FRPO), Ontario Geothermal Association (OGA), Ontario Greenhouse Vegetable Growers (OGVG), Ontario Sustainable Energy Association (OSEA), and School Energy Coalition (SEC).

Schedule of Procedural Steps

The OEB is making provision for the following procedural steps in the order below. The OEB may issue further procedural orders from time to time.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. A transcribed technical conference will be convened on **June 27, 2018** beginning at 9:30 a.m. Parties intending to participate in the technical conference are required to file with the OEB and copy all other parties confirmation of the particular areas of the evidence that they seek to explore, or seek clarification on, by **June 25, 2018**.

All filings to the OEB must quote the file number, EB-2017-0319, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.oeb.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
