## Re: Enbridge Gas Distribution Inc. 2019/2020 Cap and Trade Compliance Plan ("Application")

Enbridge recognizes that under the Board's Cap and Trade Framework, a 2019/2020 Compliance Plan is due on or before August 1, 2018. Enbridge respectfully requests that the Board consider extending the deadline to a date which is two months post the issuance of a Decision on its 2018 Cap & Trade Compliance Plan which is currently in the argument phase in EB-2017-0224/0255/0275. An extension of two months is required to adequately consider and develop a two-year Compliance Plan. Enbridge's request for an extended deadline is necessary because:

- Reply argument in the 2018 Compliance Plan proceeding is not required until June 21. A Decision and Order may not be available prior to the August 1, 2018 deadline for the 2019/2020 Application.
- There may be changes to Ontario's Cap and Trade and energy conservation markets not known to us in the short-term.
- The deadline for the Provincial governments to announce their intent related to carbon pricing is September 1, 2018. Filing the 2019/2020 Application after this date would benefit from a further important signal around which to plan for 2019/2020.
- It is more likely that the new Ontario government might signal their intentions related to low carbon activities and energy efficiency (as well as Cap & Trade itself) by the later filing date.
- As demonstrated by the Utilities this year, they are capable of continuing to meet their Cap & Trade Compliance obligations without harm to ratepayers despite not having a final Decision and Order from the Board in place in respect of their 2018 Compliance Plans.
