Application for electricity distribution rates beginning May 1, 2018

PROCEDURAL ORDER NO. 5 July 6, 2018

Essex Powerlines Corporation (Essex Powerlines) filed a cost of service application with the Ontario Energy Board (OEB) on August 28, 2017 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Essex Powerlines charges for electricity distribution, to be effective May 1, 2018.

The School Energy Coalition (SEC), Vulnerable Energy Consumers Coalition (VECC) and Hydro One Networks Inc. (HONI) applied for, and were granted, intervenor status. Following a settlement conference on March 13 and 14, 2018. Essex Powerlines, SEC, VECC, and HONI (collectively the parties) reached a partial settlement and filed a settlement proposal with the OEB on April 13, 2018 (settlement proposal) in which all issues were settled with the exception of one issue.

The parties proposed in the settlement proposal that the unsettled issue should be resolved through written submissions. The OEB accepted the parties' proposed process and established a schedule for written submissions in Procedural Order No. 4 (PO#4)

On July 5, 2018, the OEB received a letter from SEC requesting an extension of the intervenor submission filing deadline of July 6, 2018 as contemplated PO#4, to July 11, 2018.

The OEB makes provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. Intervenors shall file written submissions, if any, with the OEB and serve them on all parties by **July 11, 2018**.
2. Essex Powerlines shall file with the OEB its reply submission, if any, and serve it on all intervenors by **July 23, 2018**.

All filings to the OEB must quote the file number, EB-2017-0039, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.oeb.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
