Re: Service Area Amendment Revision - Alectra Utilities Corporation

Alectra Utilities Corporation (“Alectra”) is a licensed electricity distributor, operating under Electricity Distribution Licence No. ED-2016-0360. Among other communities, comprising its service territory, Alectra provides service to customers in the Township of Essa. Alectra requests its service area, as described in Schedule 1 of the Distribution License, be amended to include the property located at 596 VICTORIA ST. E., ESSA, and to exclude 594 VICTORIA ST. E., ESSA from the Applicant’s service area.

This revision is filed as a result of a minor imprecision in the joint service area amendment application filed by Alectra and Hydro One Networks Inc. (“Hydro One”), as explained below.

On June 14, 2017, Hydro One and Alectra filed a joint application for combined service area amendments and sale of assets, in order to eliminate all load transfer arrangements between the two distributors. The application was assigned file number EB-2017-0237.

The application sought, *inter alia*, to transfer 205 Hydro One customers to Alectra. Amongst those customers, was a customer, whose municipal address was identified as 594 VICTORIA ST. E., ESSA (the “Municipal Address”). On September 21, the OEB rendered its decision, granting the application and amending Alectra’s service area as requested.

Recently, while implementing the OEB decision, Alectra and Hydro One became aware that the Municipal Address is not correct, and it should read 596 VICTORIA ST. E., ESSA. This oversight was a result of different identifications of the same property in Alectra’s and Hydro One’s Geographic Information Systems (“GIS”).

Included herewith as Attachment 1 are the respective GIS maps, depicting the property.

Alectra has carried out a thorough investigation of the aforementioned discrepancy, including searching the Simcoe County land registry and conducting a site visit. As a result, Alectra and Hydro One are in agreement that the property should be identified as 596 VICTORIA ST. E., ESSA.

Alectra notes that no person will be affected as a result of this revision. The customer residing on the property was notified of the transfer as part of the previous service area amendment application (EB-2017-0237). The Distribution Licence of Hydro One does not need to be amended, since it states that the area served by Alectra Utilities Corporation in the Township of Essa is not served by Hydro One.

Alectra respectfully request that Schedule 1 of Alectra Utilities Corporation's (the PowerStream Rate Zone) Electricity Distribution Licence (ED-2016-0360) be amended to include the property located at 596 VICTORIA ST. E., ESSA, and to exclude 594 VICTORIA ST. E., ESSA from the Applicant's service area.

The blackline version of the relevant page of the Alectra Distribution Licence is provided as Attachment 2.
