**Re: Costs Submissions of the Métis Nation of Ontario for Participation in  
EB 2017-0364**

---

We are counsel to the Métis Nation of Ontario (“MNO”) in the above-noted matter.

The MNO was an intervenor in the above-noted matter. In the Ontario Energy Board’s (“OEB”) Decision and Order for EB-2017-0364, issued on July 19, 2018, the OEB confirmed that the MNO “was eligible to apply for an award of costs for [its] participation in the hearing of the Motion.”

The Decision and Order set out a process for the MNO to file its costs claims, requiring that it do so by July 26, 2018. The Decision and Order also required that the costs claims adhere to the direction provided in the OEB’s *Practice Direction on Costs Awards* and the OEB’s Costs Awards Tariff.

Section 5 of the OEB’s *Practice Direction on Costs Awards* (“OEB Practice Direction”) set out several criteria that the OEB will consider in determining a costs award, including that the intervenor:

- (a) participated reasonably in the process;
- (b) contributed to a better understanding by the Board of one or more of the issues in the process;
- (c) complied with the Board’s orders, rules, codes, guidelines, filing requirements and section 3.03.1 of this Practice Direction with respect to frequent intervenors, and any directions of the Board;
- (d) made reasonable efforts to combine its intervention with that of one or more similarly interested parties, and to co-operate with all other parties;

- (e) made reasonable efforts to ensure that its participation in the process, including its evidence, interrogatories and cross-examination, was not unduly repetitive and was focused on relevant and material issues;
- (f) engaged in any conduct that tended to lengthen the process unnecessarily; or
- (g) engaged in any conduct which the Board considers inappropriate or irresponsible.

Throughout this proceeding, the MNO participated responsibly, and in a manner that reflected the importance of this process to the MNO. As the MNO's legal counsel, we attended all technical conferences and hearing dates. The MNO's President, Margaret Froh, made herself available for cross-examination by Hydro One and OEB staff in person. Key MNO elected leadership travelled from their communities—the Métis communities that will be impacted by the Lake Superior Link Project—to attend the hearing.

The MNO's submissions were directly relevant to issues that the OEB had posed to Hydro One about Aboriginal consultation, specifically with regards to the Métis. As was highlighted in our cross-examination of Hydro One and final oral submissions, the Métis have to date been treated differently by Hydro One to First Nations in its consultation efforts.<sup>1</sup> Furthermore, the MNO's final oral submissions addressed the following questions posed by the OEB to all parties in the Notice of Hearing for this proceeding:

- a. Should the OEB grant an order dismissing Hydro One's Lake Superior Link application?
- d. Hydro One's transmission licence allows the OEB to order it to expand or reinforce its transmission system in order to ensure and maintain system integrity or reliable and adequate capacity and supply of electricity. What legal or other issues may arise if the OEB were to require Hydro One to reinforce the section of its transmission system that runs through the Pukaskwa National Park and to connect with the proposed NextBridge transmission line at both borders of the Park?
- g. Can NextBridge's environmental assessment work for the East-West Tie line project be used by Hydro One for the purpose of complying with Environmental Assessment Act requirements?<sup>2</sup>

At all times, the MNO complied with the OEB's timelines, including filing written evidence, and adhering to the time limits set by the OEB for its cross-examinations and oral argument. The MNO did not cross-examine all parties, but only those with information and/or expertise that the MNO deemed important and relevant to its participation (specifically the matters listed above) and final submissions.

The MNO was not able to combine its participation with that of others, since the MNO is uniquely situated. It could not, like some other Aboriginal communities, participate as part of a coalition. Similarly, the MNO's perspective and submissions, while there were some common elements with other Aboriginal intervenors, were unique and tailored to the circumstances of the MNO, as a Métis government representing two regional rights-bearing Métis communities with traditional territories that will be traversed by the proposed Lake Superior Link Project, and were informed by the MNO's unique engagement and experience throughout the designation process, NextBridge's development of the East-West Tie Project, and Hydro One's development of the LSL Project.

The MNO engaged in no conduct that would unnecessarily lengthen the proceedings, nor did it engage in any inappropriate or irresponsible conduct.

Please note that we have included certain costs in the "Other Conferences" category that did not fit elsewhere but were critical to the MNO's participation. These costs include reviewing correspondence received by the OEB after the hearing, as well as reviewing the Decision and Order, debriefing our client on the Decision and Order, and preparing this costs claim. It is our opinion that costs are all necessary aspects of the MNO's participation in this proceeding.

Further, pursuant to section 7.03 of the OEB Practice Direction, an itemized receipt for photocopying disbursements cannot be provided as this is maintained internally, and receipts are not generated. For an itemized list of the photocopying charges, please see our internal ledger, attached as Schedule "A" to this letter.

As such, on behalf of our client, we respectfully request the attached costs be awarded to the MNO by the OEB for its participation in the above-noted matter.
