Re: EB-2018-0235: Applications for Finalization of Distribution Rates October 1, 2016 to December 31, 2019

On June 29, 2018, EPCOR Natural Gas Limited Partnership ("**ENGLP**") filed the following six applications to finalize ENGLP's distribution rates for the period from October 1, 2016 to December 31, 2019:
