APPLICATION

- 5. OMLP requests that the OEB issue an order to enable the rates established as a result of this application to be become effective September 1, 2018, notwithstanding that the OEB's Decision with Reasons approving or fixing these rates and other charges may not be delivered until after that date.
- 6. OMLP also applies to the OEB for such interim order or orders approving interim rates or other charges and accounting orders as may from time to time appear appropriate or necessary.

- OMLP further applies to the OEB for the following:
 a) An exemption in whole to the Affiliate Relationships Code for Gas Utilities;
 b) An exemption in whole to the Gas Distribution Access Rule; and
 c) All necessary orders and directions to provide for pre-hearing and hearing procedures for the determination of this application.
- 8. This application is supported by written evidence and may be amended from time to time as circumstances may require.
