1. I am in the employ of Enbridge Gas Distribution Inc. ("Enbridge") and as such have knowledge of the matters hereinafter deposed to.
2. Pursuant to the August 1, 2018 Letter of Direction from the Ontario Energy Board (the "OEB" and / or the "Board"), I caused to be served by courier a copy of both the English and French versions of the Notice of Application (Exhibit "A") and Enbridge's Application (Exhibit "B") upon all affected property owners, on all encumbrancers and encumbrances with lands or interest in lands as shown by the Affidavit of Search of Title dated April 2, 2018 (Exhibit "C"). Enbridge's evidence was also served on all parties as requested, however due to the volume of the exhibits they have not been provided as an attachment to my Affidavit.
3. Pursuant to the Letter of Direction, I caused to be served by courier or registered mail a copy of the English and French versions of the Notice of Application and Enbridge's Application and Evidence on the Clerk for the City of Toronto

4. Pursuant to the Letter of Direction, I caused to be served by courier a copy of the English and French versions of the Notice of Application and Enbridge's Application the members of the Ontario Pipeline Coordinating Committee. Through correspondence with the OEB Registrar's Office, it was confirmed that the above noted parties do not require to receive a paper copy of the evidence.
5. In accordance with the Letter of Direction, attached hereto is proof, in the form of UPS courier confirmation sheets (Exhibit "D"), that the relevant Notice of Application, Enbridge's Application and Evidence was served on those parties as requested by the Board's in the Letter of Direction.
6. Pursuant to the Letter of Direction, I caused to be served by email a copy of the English and French versions of the Notice of Application and Enbridge's Application on the Métis Nation of Ontario (Exhibit "E").
7. In addition to the above mention parties, Enbridge was directed by the OEB to provide service to all indigenous communities that have been consulted or with lands or interest in lands directly affected by the propose pipeline and to all affected utilities and railway companies. There are no Indigenous communities or utilities and railway companies affected by the project.
8. In accordance with the Letter of Direction, I caused a copy of the Notice to be placed in a prominent place on Enbridge's website. Attached as Exhibit "F" is proof of the information posted to Enbridge's website.

Enbridge Gas Distribution Inc. has applied for approval to construct approximately 1.2 kilometres of natural gas pipeline in the Liberty Village area of the City of Toronto.

If approved, this pipeline project would involve reinforcement of 900 metres of existing natural gas pipeline and construction of two new segments of natural gas pipeline totaling 285 metres. Enbridge Gas Distribution Inc. says the project is needed to serve current and future load requirements in the Liberty Village area of the City of Toronto.

Enbridge Gas Distribution Inc. is also asking the OEB to approve the form of agreement it offers to landowners to use their land for routing or construction of the proposed line.

A map of the proposed pipeline project is provided below.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Enbridge Gas. During the hearing, we will question Enbridge Gas on the case. We will also hear questions and arguments from individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas' compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

Enbridge Gas' application includes a letter from the Ministry of Energy, Northern Development and Mines. That letter says that based on current information provided by Enbridge Gas, the Ministry of Energy, Northern Development and Mines is of the view that the project will not result in any appreciable adverse impacts to the asserted or established rights of any First Nation or Métis communities and that no duty to consult has been triggered. Based on this, Enbridge Gas has indicated that it will not be filing an Indigenous Consultation Report for the project. Should new project information become available that indicates a potential to impact Aboriginal or treaty rights or should an Indigenous community identify itself as being potentially affected by the project, Enbridge Gas must notify the Ministry of Energy, Northern Development and Mines and the OEB may, as part of its review of the project, be required to assess whether the duty to consult with Indigenous communities potentially affected by the proposed pipeline has been discharged with respect to the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Enbridge Gas on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **August 22, 2018** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

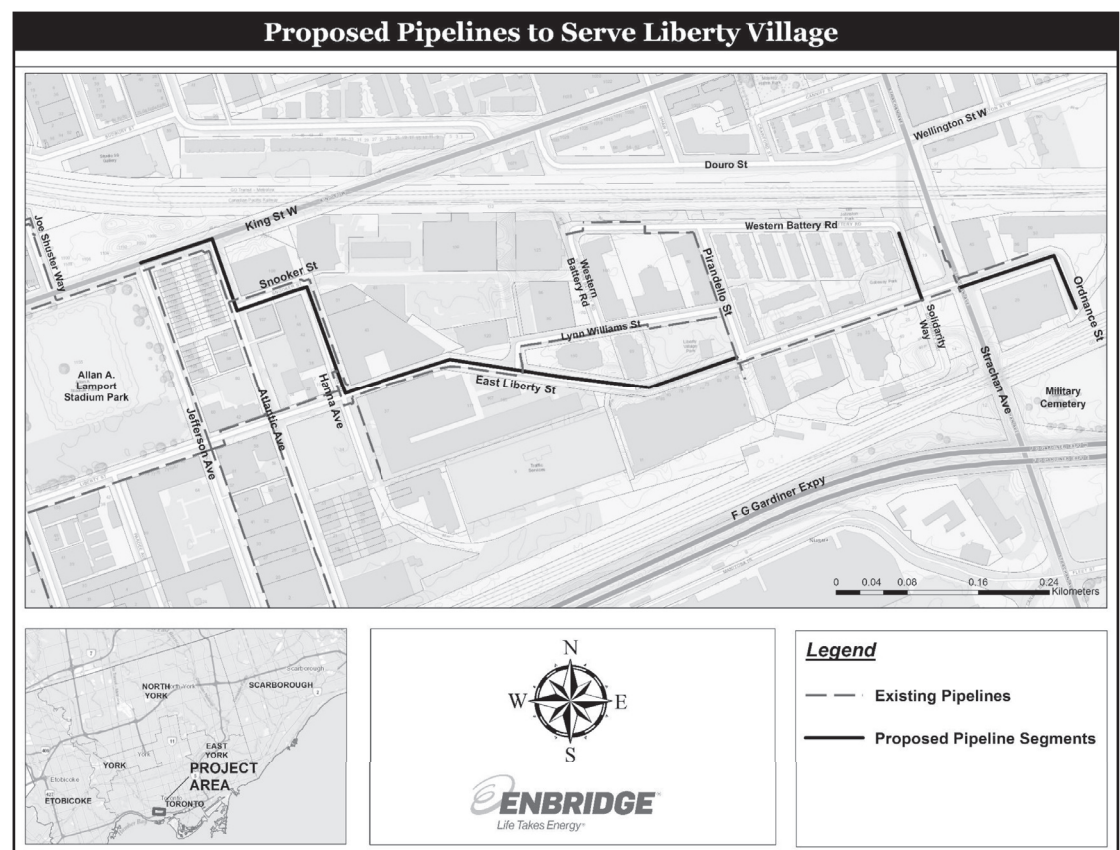
ORAL VS. WRITTEN HEARINGS

La Commission de l'énergie de l'Ontario (CEO) tiendra une audience publique afin d'étudier la demande déposée par Enbridge Gas. Au cours de l'audience, des questions seront posées sur le projet à Enbridge Gas. Nous écouterons également les questions et les arguments des consommateurs, des municipalités et de toute autre entité dont les intérêts sont en jeu. À l'issue de cette audience, la CEO prendra sa décision quant à l'approbation de la demande.

Dans le cadre de cette demande, la CEO évaluera le respect de ses directives en matière d'environnement par Enbridge Gas, en ce qui concerne l'emplacement, la construction et l'exploitation des pipelines et des installations d'hydrocarbures en Ontario.

La demande d'Enbridge Gas comprend une lettre du ministère de l'Énergie, du Développement du Nord et des Mines. Si de nouveaux renseignements sur le projet deviennent disponibles et indiquent qu'ils pourraient avoir une incidence sur les droits ancestraux ou issus de traités ou si une collectivité autochtone juge qu'elle risque d'être touchée par le projet, Enbridge Gas doit aviser le ministère de l'Énergie, du Développement du Nord et des Mines et la CEO peut, dans le cadre de l'examen du projet, être tenue d'évaluer si l'obligation de consulter les collectivités autochtones susceptibles d'être touchées par le pipeline proposé a été acquittée relativement à la demande.

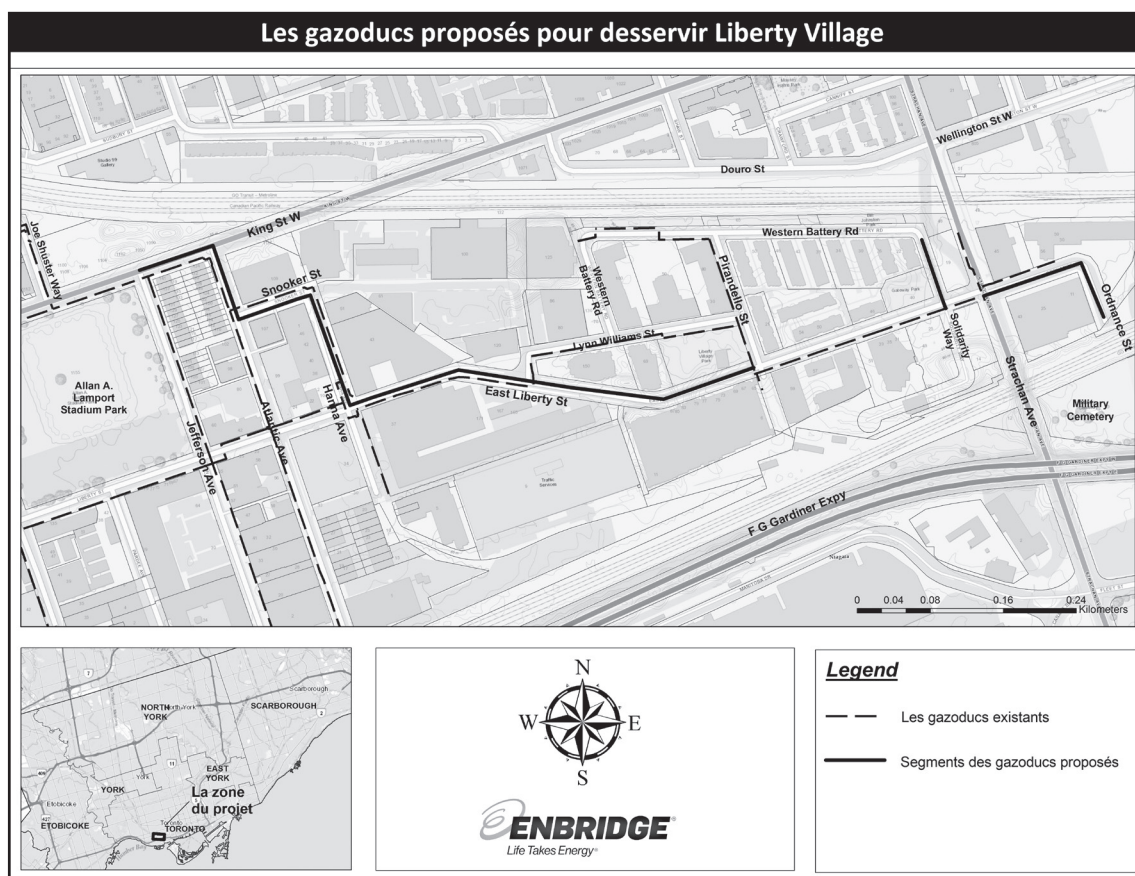

LEAVE TO CONSTRUCT APPLICATION: LIBERTY VILLAGE

1. The Applicant, Enbridge Gas Distribution Inc. (“Enbridge”) is an Ontario corporation with its head office in the City of Toronto. It carries on the business of selling, distributing, transmitting, and storing natural gas within Ontario.
2. Liberty Village is a neighborhood within the City of Toronto. A portion of the gas distribution system that feeds into Liberty Village does not have the gas capacity to support recent load requests. Enbridge has received several requests for gas distribution service from real estate developers seeking to build condominiums and mixed use buildings in Liberty Village. A reinforcement of the natural gas distribution system in Liberty Village is required to support these requests and current and future natural gas demand in the area.
3. The Liberty Village Pipeline Project (the “Project”) will make natural gas available to 7 new condominiums and mixed use towers in Liberty Village. The Project will also ensure that four hundred and eleven existing commercial, industrial and residential customers will have uninterrupted natural gas distribution service

4. Enbridge hereby applies to the Ontario Energy Board for leave to construct approximately 1.2km of natural gas pipeline in the City of Toronto. The Project is comprised of two sections of pipeline. The first section of pipeline is reinforcement to the existing distribution system and the second section of pipeline will allow the provision of gas distribution service to new customers in the Liberty Village. A map showing the proposed pipeline route can be found in Exhibit B, Tab 1, Schedule 1, Attachment 1. /u
5. The first section of the proposed pipeline is 900 m of Nominal Pipeline Size ("NPS 8") Intermediate Pressure ("IP") steel natural gas main originating at King Street and Jefferson Avenue where it connects to the existing NPS 12 IP steel natural gas main. The first section of pipeline terminates at the existing NPS 6 IP gas main at Pirandello Street. The second section of the proposed pipeline consists of two individual segments of pipe. The first segment, which is approximately 200 m of NPS 6 IP plastic gas main, starts at Strachan Avenue and Ordnance Street heading east on Ordnance Street and following Ordnance Street south for approximately 90 m. The second segment is approximately 85 m of NPS 4 IP plastic gas main which will begin on Western Battery Road where it will connect to a existing gas main at the intersection of Western Battery Road and East Liberty Street. /u
6. The route and location for the proposed facilities associated with the Project were selected by an independent environmental consultant through the process outlined in the Ontario Energy Board's *"Environmental Guidelines for the Location, Construction, and Operation of Hydrocarbon Pipelines and Facilities in Ontario"* (7th Edition, 2016) (the "Guidelines"). Input from the public was sought during the route selection process and was incorporated into the final route decision.
7. Pursuant to the Guidelines, Enbridge requested that the Ministry of Energy (the "MOE") determine if there is any Duty to Consult requirements for the Project.

The MOE has not delegated the procedural aspects of the Duty to Consult for the Project to Enbridge.

8. To meet the in-service date of February 2019 and to meet customer gas demand requirements, Enbridge must commence construction by September 2018. The proposed construction schedule will enable customers to use natural gas for the 2018/2019 heating season.
9. Enbridge requests this Application proceed by way of written hearing in English.
10. Enbridge requests the Board issue the following Orders:/u
 - (i) pursuant to section 90 of the *Ontario Energy Board Act*, 1988, S.O., 1988, c-15, Schedule B, an Order granting leave to construct the pipelines.
 - (ii) pursuant to section 97 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c-15, Schedule B, an Order approving the form of easement agreements found at Exhibit F, Tab 1, Schedule 3.





Overview

Enbridge Gas Distribution Inc. ("Enbridge") is proposing to construct approximately 1.2 km of natural gas pipeline within Liberty Village. The Project will serve to supply gas to additional development, and reinforce the existing gas infrastructure to support future growth in the community.

Amended Preferred Route

The amended Preferred Route for the new gas pipeline consists of two sections having a total length of 1.2 km. Section 1 of the new pipeline consists of 900 m of 8-inch Intermediate Pressure steel pipe beginning at King Street West and Jefferson Avenue. It extends eastwards along King Street before being directed south onto Atlantic Avenue where it then continues east along Snooker Street. It turns south onto Hanna Avenue and continues toward East Liberty Street. Finally, it continues eastwards along East Liberty Street and connects with an existing gas main at Pirandello Street.

Section 2 of the new pipeline consists of two individual segments of pipe. The first segment included in the original Preferred Route, is 200 m of 6-inch Intermediate Pressure polyethylene pipe beginning at Strachan Avenue and Ordinance Street, continuing east, before heading south where it ends. The second segment, identified as the Amendment to the Preferred Route is 85 m of 4-inch Intermediate Pressure polyethylene pipe beginning on Western Battery Road and connecting to an existing gas main at the intersection of Western Battery Road and East Liberty Street.

The proposed natural gas pipeline will be located mainly within the municipal rights-of-way (ROW).

OEB Notice of Application

On August 1, 2018, the OEB issued the Notice of Application (English) (French) with respect to the filing by Enbridge for a leave to construct application for approval to construct a natural gas pipeline in the Liberty Village area of the City of Toronto.

Request for intervenor status are due to the OEB by August 22, 2018.
