Provision of Supplemental Supporting Documentation Requested by the OEB

We are counsel to the Intervenor Métis Nation of Ontario ("MNO") in the above-noted proceeding.

In the Ontario Energy Board's ("OEB") Decision and Order for EB-2017-0364, issued on July 19, 2018, the OEB confirmed that the MNO "was eligible to apply for an award of costs for [its] participation in the hearing of the Motion." We submitted a claim for participation costs on behalf of the MNO on July 26, 2018 ("MNO Cost Claim").

On August 14, 2018, the OEB requested that we provide dockets for the legal fees set out in the MNO Cost Claim. The dockets for Jason Madden (Partner), Megan Strachan (Associate) and John Wilson (Law Clerk), are attached.

As stated in our covering letter to the OEB that accompanied the MNO Cost Claim, these legal fees are reasonable given the scope of the proceeding which involved numerous intervenors, several complex issues, voluminous evidence, and multiple days of technical conferences and hearings. As is clear from the dockets, a junior associate (Megan Strachan) and law clerk (John Wilson) were used whenever possible, resulting in lower legal fees.

As such, on behalf of our client, we respectfully request the that the costs set out in the MNO Cost Claim, supported by the documents previously submitted as well as the dockets attached here, be awarded to the MNO by the OEB for its participation in the above-noted proceeding.
