ENBRIDGE GAS DISTRIBUTION INC.

**Application for quarterly rate adjustment mechanism commencing
July 1, 2018**

INTRODUCTION AND SUMMARY

Enbridge Gas Distribution Inc. (Enbridge Gas) filed an application with the Ontario Energy Board (OEB) dated June 11, 2018 for an order approving or fixing rates for the sale, distribution, transmission, and storage of natural gas effective July 1, 2018.

On June 26, 2018, Enbridge Gas filed a letter with the OEB indicating that it would be unable to implement new rates under the Quarterly Rate Adjustment Mechanism (QRAM) as of July 1, 2018 if the rate orders were not issued by June 27, 2018. Enbridge Gas proposed that, in such an event, the current rates remain in place until the next QRAM cycle in the fall.

The OEB issued a letter dated June 28, 2018 accepting the utilities' proposal to discontinue the July 1, 2018 QRAM in favour of deferring the setting of new QRAM rates, and the disposition of their purchased gas variance account balances, to the October 1, 2018 QRAM. Enbridge Gas' current rate order therefore remains in effect.

The OEB issued its Procedural Order No. 1 on July 19, 2018 which, among other things, directed eligible parties to file their cost claims with the OEB and Enbridge Gas no later than August 1, 2018. Enbridge Gas had until August 8, 2018 to object to any aspect of the costs claimed. Any responses to Enbridge Gas' concerns were to be filed with the OEB and Enbridge Gas by August 15, 2018.

The Canadian Manufacturers & Exporters and the Industrial Gas Users Association filed cost claims with the OEB and copied Enbridge Gas. On August 8, 2018, Enbridge Gas filed a letter stating that it had no objection to the cost claims.

OEB Findings

I have reviewed the cost claims filed and found them to be reasonable and find both parties to be entitled to 100% of their reasonably incurred costs of participating in this proceeding.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. Pursuant to section 30 of the *Ontario Energy Board Act, 1998*, Enbridge Gas shall pay:
