**Re: Amendment to Schedule 1 of NextEra Energy Canadian Operating Services, Inc.
electricity generation licence to add Cedar Point II generation facility**

NextEra Energy Canadian Operating Services, Inc. ("**NECOSI**") and Cedar Point II Limited Partnership ("**Cedar Point II**") hereby request that (i) Schedule 1 of NECOSI's electricity generation licence EG-2012-0311 be amended to add the operation of the Cedar Point II wind generation facility; and (ii) Cedar Point II's electricity generation licence (EG-2015-0137) be amended to delete "operation" of the facility from Schedule 1.

Details of the above-noted Schedule 1 amendments are set out below.

Name and address of generation facility and size, fuel type and number of units

The facility is known as the Cedar Point II wind generation facility. It is a 100 MW electricity generation facility using wind energy as renewable fuel. The address of the facility is 5767 Cedar Point Line, Lambton Shores, Ontario, as currently set out in EG-2015-0137.

Name of owner and operator

The owner of the Cedar Point II facility is Cedar Point II Limited Partnership. The operator of the Cedar Point II facility is NECOSI. As noted above, NECOSI is a qualified electricity generation licence holder under licence EG-2012-0311.

Standard offer program contracts

Cedar Point II has a Feed-in-Tariff contract with the IESO.

Details of requested amendments

As noted above, the following amendments are requested:

- amendment of Schedule 1 of NECOSI's electricity generation licence EG-2012-0311 to add operation of the Cedar Point II facility; and
- amendment of Schedule 1 of Cedar Point II's electricity generation licence EG-2015-0137 to remove the words "and operation"

There is no change to contact names or addresses in regards to NECOSI or Cedar Point II.

Request for disposal of amendments without a hearing

NECOSI and Cedar Point II request that the amendments be processed without a hearing pursuant to section 21(4)(b) of the *Ontario Energy Board Act, 1998*, as no person will be adversely affected by the processing of these amendments.
