b) arrange for the service of the enclosed Notice, in the exact form accompanying this letter by email on any customers for which EPCOR Natural Gas has an email address and appropriate permissions to use the email address to send utility or regulatory information with the following email message:

"EPCOR Natural Gas Limited Partnership has applied to the Ontario Energy Board to increase our natural gas distribution rates. Please review the Ontario Energy Board's Notice of Hearing to learn more and to find out how you can participate in the Ontario Energy Board's hearing." - 4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.
