1. I am in the employ of Enbridge Gas Distribution Inc. ("Enbridge") and as such have knowledge of the matters hereinafter deposed to.
2. Pursuant to the August 30, 2018 Letter of Direction from the Ontario Energy Board (the "OEB" and / or the "Board"), I caused to be served by courier a copy of both the English and French versions of the Notice of Application (Exhibit "A") and Enbridge's Application (Exhibit "B") upon all affected property owners, on all encumbrancers and encumbrances with lands or interest in lands as shown by the Affidavit of Search of Title dated May 18, 2018 (Exhibit "C") and the Clerk for the City of Toronto, Enbridge's evidence was also served on all parties as requested, however due to the volume of the exhibits they have not been provided as an attachment to my Affidavit.
3. Pursuant to the Letter of Direction, I caused to be served by courier a copy of the English and French versions of the Notice of Application and Enbridge's Application to the members of the Ontario Pipeline Coordinating Committee and affected

utilities. Through correspondence with the OEB Registrar's Office, it was confirmed that the above noted parties do not require a paper copy of the evidence. The letter to parties indicated that a paper copy was available upon request and I provided a link to Enbridge's website where the application and evidence has been made available.

- 4. In accordance with the Letter of Direction, attached hereto is proof, in the form of UPS courier confirmation sheets and Canada Post confirmation (Exhibit "D"), that the relevant Notice of Application, Enbridge's Application and Evidence was served on those parties as requested by the Board's in the Letter of Direction.
- 5. Pursuant to the Letter of Direction, I caused to be served by email a copy of the English and French versions of the Notice of Application and Enbridge's Application on the Métis Nation of Ontario (Exhibit "E").
- 6. In addition to the above mention parties, Enbridge was directed by the OEB to provide service to all indigenous communities that have been consulted or with lands or interest in lands directly affected by the propose pipeline. There are no Indigenous communities affected by the project. Further, Enbridge was directed to provide service to any affected railway companies. There are no railway companies affected by the project.

Enbridge Gas Distribution Inc. has applied for approval to construct approximately 3.2 kilometres of natural gas pipeline in the North York area of the City of Toronto.

If approved, this pipeline project would involve the construction of 3.2 kilometres of natural gas pipeline and ancillary facilities. Enbridge Gas Distribution Inc. says the project is needed to serve current and future load requirements in the North York area of the City of Toronto.

Enbridge Gas Distribution Inc. is also asking the OEB to approve the form of agreement it offers to landowners to use their land for routing or construction of the proposed line.

A map of the proposed pipeline project is provided below.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Enbridge Gas. During the hearing, we will question Enbridge Gas on the case. We will also hear questions and arguments from individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas' compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

Enbridge Gas' application includes a letter from the Ministry of Energy, Northern Development and Mines. That letter says that based on current information provided by Enbridge Gas, the Ministry of Energy, Northern Development and Mines is of the view that the project will not result in any appreciable adverse impacts to the asserted or established rights of any First Nation or Métis communities and that no duty to consult has been triggered. Should new project information become available that indicates a potential to impact Aboriginal or treaty rights or should an Indigenous community identify itself as being potentially affected by the project, Enbridge Gas must notify the Ministry of Energy, Northern Development and Mines and the OEB may, as part of its review of the project, be required to assess whether the duty to consult with Indigenous communities potentially affected by the proposed pipeline has been discharged with respect to the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Enbridge Gas on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **September 19, 2018** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

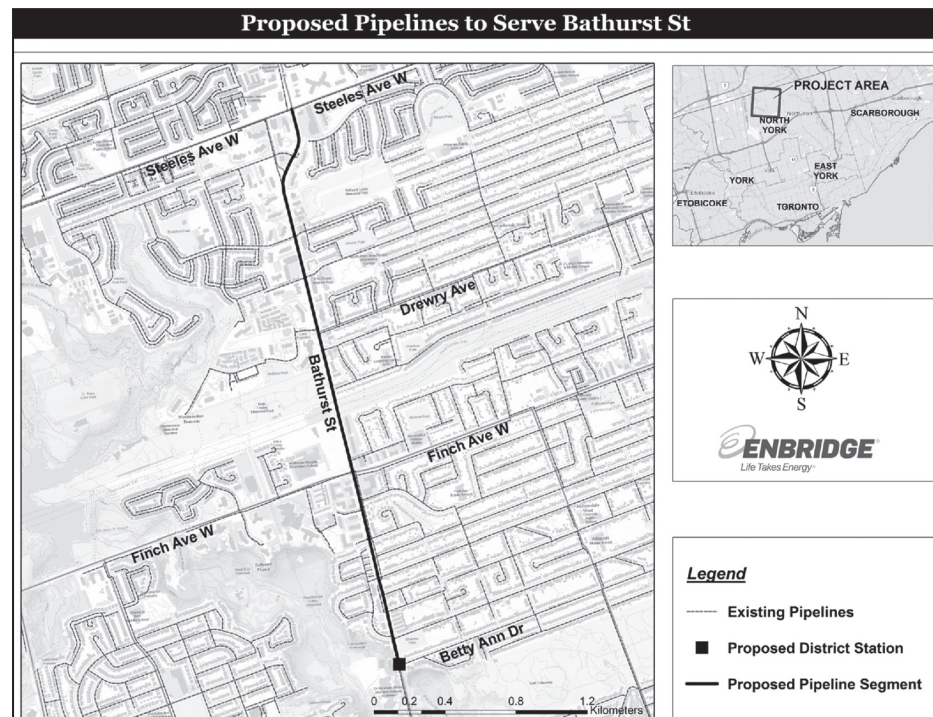
ORAL VS. WRITTEN HEARINGS

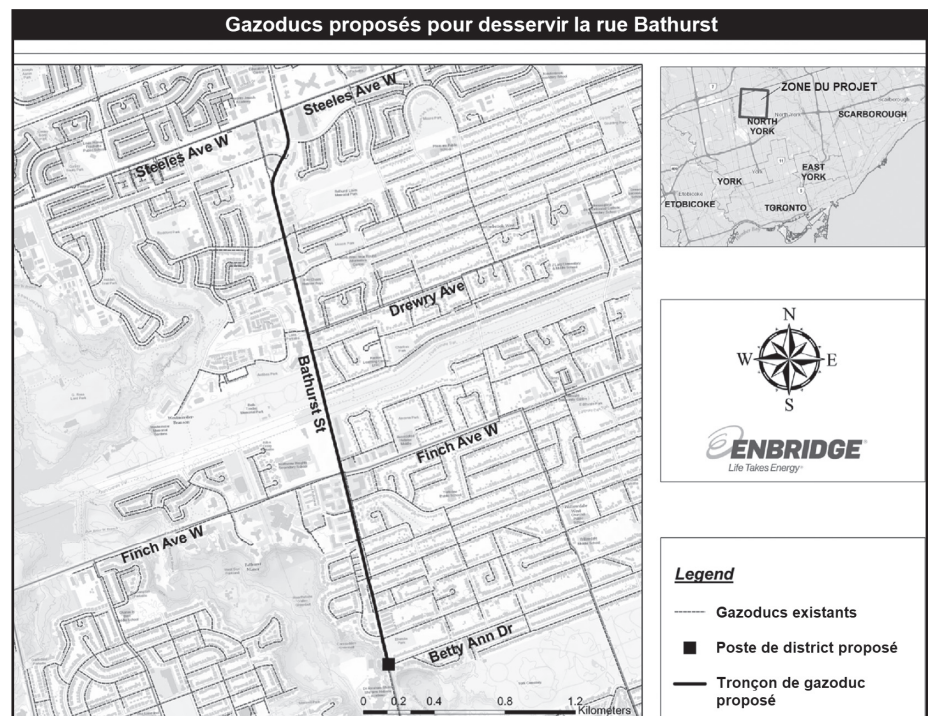

LEAVE TO CONSTRUCT APPLICATION: BATHURST REINFORCEMENT

1. The Applicant, Enbridge Gas Distribution Inc. (“Enbridge”) is an Ontario corporation with its head office in the City of Toronto. It carries on the business of selling, distributing, transmitting, and storing natural gas within Ontario.
2. The Bathurst Reinforcement Project (the “Project”) is being built to serve a large portion of North York. Currently, the customer growth in the area has reduced capacity within the gas network servicing the area. A reinforcement of the natural gas distribution system to this portion of the neighborhood will increase energy supply for residential and commercial customers.
3. Enbridge hereby applies to the Ontario Energy Board (the “Board”) for leave to construct approximately 3.2 km of nominal pipe size (“NPS”) 12 inch high pressure steel gas pipeline and approximately 20 m of NPS 8 inch steel intermediate pressure pipeline in the City of Toronto. Construction of a new district station will also be required. These are required to connect the existing NPS 12 high pressure steel gas main on Steeles Ave to the NPS 8 intermediate pressure steel gas main on Betty Ann

Dr in order to reinforce the existing supply and provide supply for new customers on this network. Preferred route starts at the intersection of Bathurst St and Steeles Ave, heading south along Bathurst St and ending near the intersection of Betty Ann Drive and Bathurst St. The new district station will be constructed at the intersection of Betty Ann Drive and Bathurst St. A map showing the proposed pipeline route can be found in Exhibit B, Tab 1, Schedule 1, Attachment 1.

4. The route and location for the proposed facilities associated with the Project were selected by an independent environmental consultant through the process outlined in the Ontario Energy Board's "*Environmental Guidelines for the Location, Construction, and Operation of Hydrocarbon Pipelines and Facilities in Ontario*" (7th Edition, 2016) (the "Guidelines"). Input from the public was sought during the route selection process and was incorporated into the final route decision.
5. Pursuant to the Guidelines, Enbridge requested that the Ministry of Energy (the "MOE") determine if there is any Duty to Consult requirements for the Project. The MOE has not delegated the procedural aspects of the Duty to Consult for the Project to Enbridge.
6. To meet the in-service date of December 2019 and to meet customer gas demand requirements, Enbridge must commence construction by spring 2019. The proposed construction schedule will enable customers to use natural gas for the 2019/2020 heating season.
7. Enbridge requests this Application proceed by way of written hearing in English.
8. Enbridge requests the Board issue the following orders:
 - (i) pursuant to section 90 of the *Ontario Energy Board Act*, 1988, S.O., 1988, c-15, Schedule B, an Order granting leave to construct the pipelines.

- (ii) pursuant to section 97 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c-15, Schedule B, an Order approving the form of easement agreements found at Exhibit F, Tab 1, Schedule 3.

On August 1, 2018, Enbridge filed an application with the Board for approval to construct up to 3.6 km of nominal pipe size ("NPS") 12 inch natural gas pipeline in North York (the "Project"). The Project is a reinforcement pipeline and as such will allow Enbridge to continue providing gas distribution service to customers in the area and meet gas demand stemming from customer growth in the area.

On August 30, 2018, the Board issued the Notice of Application (English and French) and the Letter of Direction for the proceeding. The Board has directed Enbridge to serve the Notice of Application and Enbridge's application and evidence on the Métis Nations of Ontario, Lands, Resources and Consultation Office.
