### THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Enbridge Gas. During the hearing, we will question Enbridge Gas on the case. We will also hear questions and arguments from individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas' compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

Enbridge Gas' application includes a letter from the Ministry of Energy, Northern Development and Mines. That letter says that based on current information provided by Enbridge Gas, the Ministry of Energy, Northern Development and Mines is of the view that the project will not result in any appreciable adverse impacts to the asserted or established rights of any First Nation or Métis communities and that no duty to consult has been triggered. Should new project information become available that indicates a potential to impact Aboriginal or treaty rights or should an Indigenous community identify itself as being potentially affected by the project, Enbridge Gas must notify the Ministry of Energy, Northern Development and Mines and the OEB may, as part of its review of the project, be required to assess whether the duty to consult with Indigenous communities potentially affected by the proposed pipeline has been discharged with respect to the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

You have the right to information regarding this application and to be involved in the process.

### LEAVE TO CONSTRUCT APPLICATION: BATHURST REINFORCEMENT

- The Applicant, Enbridge Gas Distribution Inc. ("Enbridge") is an Ontario corporation
  with its head office in the City of Toronto. It carries on the business of selling,
  distributing, transmitting, and storing natural gas within Ontario.
- 2. The Bathurst Reinforcement Project (the "Project") is being built to serve a large portion of North York. Currently, the customer growth in the area has reduced capacity within the gas network servicing the area. A reinforcement of the natural gas distribution system to this portion of the neighborhood will increase energy supply for residential and commercial customers.
- 3. Enbridge hereby applies to the Ontario Energy Board (the "Board") for leave to construct approximately 3.2 km of nominal pipe size ("NPS") 12 inch high pressure steel gas pipeline and approximately 20 m of NPS 8 inch steel intermediate pressure pipeline in the City of Toronto. Construction of a new district station will also be required. These are required to connect the existing NPS 12 high pressure steel gas main on Steeles Ave to the NPS 8 intermediate pressure steel gas main on Betty Ann

Dr in order to reinforce the existing supply and provide supply for new customers on this network. Preferred route starts at the intersection of Bathurst St and Steeles Ave, heading south along Bathurst St and ending near the intersection of Betty Ann Drive and Bathurst St. The new district station will be constructed at the intersection of Betty Ann Drive and Bathurst St. A map showing the proposed pipeline route can be found in Exhibit B, Tab 1, Schedule 1, Attachment 1.

- 4. The route and location for the proposed facilities associated with the Project were selected by an independent environmental consultant through the process outlined in the Ontario Energy Board's "Environmental Guidelines for the Location, Construction, and Operation of Hydrocarbon Pipelines and Facilities in Ontario" (7<sup>th</sup> Edition, 2016) (the "Guidelines"). Input from the public was sought during the route selection process and was incorporated into the final route decision.
- Pursuant to the Guidelines, Enbridge requested that the Ministry of Energy
  (the "MOE") determine if there is any Duty to Consult requirements for the Project.
  The MOE has not delegated the procedural aspects of the Duty to Consult for the
  Project to Enbridge.
- To meet the in-service date of December 2019 and to meet customer gas demand requirements, Enbridge must commence construction by spring 2019. The proposed construction schedule will enable customers to use natural gas for the 2019/2020 heating season.
- 7. Enbridge requests this Application proceed by way of written hearing in English.
- 8. Enbridge requests the Board issue the following orders:
  - (i) pursuant to section 90 of the *Ontario Energy Board Act*,1988, S.O., 1988, c-15, Schedule B, an Order granting leave to construct the pipelines.


