## INTRODUCTION AND SUMMARY

On November 16, 2015, the Ontario Energy Board (OEB) released its *Regulated Price Plan Roadmap*. The Roadmap sets out a five-point plan to be implemented over the course of the next 3 to 5 years. This multi-year process will undertake a comprehensive revamping of the Regulated Price Plan (RPP) that will make incremental changes over the course of the plan to provide consumers with an adequate amount of time to adjust to the changes. Through this plan, the OEB will redesign the RPP to better respond to policy objectives, improve system efficiency, and give greater consumer control. It also commits the OEB to look at the way in which all Class B customers are charged for electricity in Ontario. The goal of this review is to ensure that the RPP is able to meet the challenges of the future. The Report is available on the [OEB's website](#).

On July 18, 2016 the Ontario Energy Board (OEB) released its *Regulated Price Plan Roadmap: Guideline for Pilot Projects on RPP Pricing*. The Guidelines establish the OEB's objectives for RPP pilots, identifies priority treatments for price and non-price pilots, and lays out a framework for electricity distributors to design, implement, and evaluate these pilots. Since the release of the Guidelines the OEB has reviewed and approved 4 RPP pilots that span 9 distributors and 7 alternative RPP price plans.

The OEB has determined that the costs of this initiative will be recovered under section 30 of the Act from all rate-regulated licensed electricity distributors. The costs are to be apportioned among all rate-regulated licensed electricity distributors in the same manner as under the OEB's Cost Assessment Model.

On February 9, 2016, the OEB issued a letter giving notice of changes to its Cost Assessment Model. Specifically, under the revised Cost Assessment Model, cost assessments for distributors are now based on customer numbers rather than revenues. The OEB considers it appropriate to apportion cost awards for this initiative in a manner consistent with the revised Cost Assessment Model. The OEB has therefore determined that costs awarded will be apportioned within the distributor class based on customer count. Schedule A has been prepared accordingly.

The OEB's costs under this initiative, between March 1, 2017 and August 31, 2018, amount to \$136,982.12. These costs are associated with ongoing consultant support in the design of robust and consistent Evaluation Measurement and Verification plans in respect of 4 RPP pilots as well as the establishment of an economic framework to evaluate alternative Class B rate design options.

## Process for Paying the Cost Awards

The OEB will use the process set out in section 12 of the *Practice Direction on Cost Awards* to implement the payment of the cost awards. Therefore, the OEB will act as a clearing house for all payments of cost awards relating to this consultation process. Invoices will be issued to all licensed electricity distributors at the same time as invoices for cost assessments are made under section 26 of the Act. The practice of the OEB is to issue to each licensed electricity distributor one invoice that covers all cost awards payable by that distributor for the relevant period. As a result, the invoice may cover cost awards payable in relation to a number of initiatives, including this one.

## THE ONTARIO ENERGY BOARD THEREFORE ORDERS THAT:

1. The Entities listed in Schedule “A” (attached hereto) shall pay the OEB’s costs of, and incidental to, this initiative.
2. Payment of the OEB’s costs referred to in paragraph 1 shall be made to the OEB in accordance with the invoice issued to each licensed electricity distributor, and shall be due at the same time as cost assessments under section 26 of the Act are due.
