The Ontario Energy Board (OEB) has now issued its Notice of Hearing for the abovementioned application for approval to transfer EPCOR Southern Bruce Gas Inc.'s (EPCOR Southern Bruce) certificates of public convenience and necessity to EPCOR Natural Gas Limited Partnership (EPCOR Natural Gas) (Notice). - a. arrange for the service of the enclosed Notice, in the exact form accompanying this letter and the application, directly on each of the Clerks of the Municipality of Arran-Elderslie, the Municipality of Kincardine and the Township of Huron-Kinloss.
  - b. arrange for the service of the enclosed Notice, in the exact form accompanying this letter and the application, directly on all intervenors in Phase II of EB-2016-0137/EB-2016-0138/EB-2016-0139.
2. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at each of EPCOR Southern Bruce's and EPCOR Natural Gas' offices and in a prominent place on each of EPCOR Southern Bruce's and EPCOR Natural Gas' websites.
3. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 and 2 above immediately thereafter.
4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
