Enbridge Gas Distribution Inc.

**Application for leave to construct 3.2 kilometres of natural gas pipeline in the
North York area of the City of Toronto**

PROCEDURAL ORDER NO. 1

September 21, 2018

On August 1, 2018, Enbridge Gas Distribution Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) under section 90(1) and section 97 of the *Ontario Energy Board Act, 1998* for an order granting leave to construct approximately 3.2 kilometres of natural gas pipeline in the North York area of the City of Toronto.

The OEB issued a Notice of Hearing on August 30, 2018. The last date for intervention was September 19, 2018. School Energy Coalition (SEC) applied for intervenor status and cost eligibility. No objection was received from Enbridge Gas.

SEC is approved as an intervenor and eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards* in relation to Enbridge Gas' request outlined above. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. SEC and OEB staff shall request any relevant information and documentation from Enbridge Gas that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Enbridge Gas by **October 1, 2018**.

2. Enbridge Gas shall file with the OEB complete responses to all interrogatories and serve them on SEC by **October 11, 2018**.
3. Unless the OEB orders otherwise, SEC and OEB staff may file any written submission with the OEB and serve them on Enbridge Gas by **October 23, 2018**.
4. Unless the OEB orders otherwise, Enbridge Gas may file a written reply submission with the OEB and serve it on SEC by **November 6, 2018**.

All filings to the Board must quote the file number, EB-2018-0097 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
