



ONTARIO POWER GENERATION INC.

Ontario Power Generation Inc. has applied to recover certain account balances and to raise its payment amounts.

Learn more. Have your say.

Ontario Power Generation Inc. has applied to the Ontario Energy Board for approval to recover, over a three-year period, the 2017 year-end balances in certain deferral and variance accounts related to its nuclear generating facilities and most of its hydroelectric generating facilities beginning on January 1, 2019.

Ontario Power Generation Inc. has also applied to increase the amount it charges for the output of most of its hydroelectric generating facilities for 2019 using an Ontario Energy Board-approved formula that is tied to inflation and other factors intended to promote efficiency.

If the application is approved as filed, Ontario Power Generation Inc. has calculated that the monthly bill for a typical residential customer would increase by \$1.39 in 2019 and by \$0.06 in 2020, and decrease by \$0.29 in 2021. These amounts do not reflect any impact of the Fair Hydro Plan. Other customers, including businesses, will also be affected. The balances in some deferral and variance accounts will continue to be recovered in future years but the recovery mechanism will be determined in a future proceeding.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Ontario Power Generation Inc.'s request. We will determine whether the company has used the applicable formulas required by the OEB and whether to approve Ontario Power Generation Inc.'s request to recover the balances in the deferral and variance accounts. We will also hear questions and arguments from individuals and groups that represent consumers of electricity. At the end of this hearing, the OEB will decide what, if any, increase will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review Ontario Power Generation Inc.'s application on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **October 3, 2018** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

LEARN MORE

These payment amounts relate to generation from Ontario Power Generation Inc.'s nuclear facilities and most of its hydroelectric facilities. They make up part of the Electricity line on your bill. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.



AVIS DE LA COMMISSION DE L'ÉNERGIE DE L'ONTARIO ONTARIO POWER GENERATION INC.

Ontario Power Generation Inc. a présenté une requête en vue de recouvrer certains soldes de compte et d'augmenter le montant de ses paiements.

Apprenez-en plus. Donnez votre avis.

Ontario Power Generation Inc. a demandé à la Commission de l'énergie de l'Ontario l'autorisation de recouvrer, sur une période de trois ans, les soldes de fin d'exercice 2017 de certains comptes de report et d'écart relatifs à ses centrales nucléaires et à la plupart de ses centrales hydroélectriques à compter du 1^{er} janvier 2019.

Ontario Power Generation Inc. a également déposé une requête en vue d'augmenter le montant qu'elle facture pour la production de la plupart de ses centrales hydroélectriques en 2019 à l'aide d'une formule, approuvée par la Commission de l'énergie de l'Ontario, liée à l'inflation et à d'autres facteurs visant à promouvoir l'efficience.

Si la requête est approuvée telle quelle, Ontario Power Generation Inc. a calculé que la facture mensuelle d'un consommateur résidentiel moyen augmenterait de 1,39 \$ en 2019 et de 0,06 \$ en 2020, et diminuerait de 0,29 \$ en 2021. Ces montants ne reflètent pas les répercussions du Plan pour des frais d'électricité équitables. D'autres clients, notamment les entreprises, seront également touchés. Le recouvrement des soldes de certains comptes de report et d'écart continuera dans les années à venir, mais le mécanisme de recouvrement sera déterminé dans le cadre d'une prochaine procédure.
