operated by OM Limited Partnership's affiliate

PROCEDURAL ORDER NO. 1

September 25, 2018

OM Limited Partnership (OMLP) filed an application dated August 13, 2018 with the Ontario Energy Board (OEB) pursuant to section 36 of the *Ontario Energy Board Act, 1998*, for an order or orders approving a rate to supply its locally produced natural gas to a new greenhouse facility owned and operated by its affiliate Maricann Group Incorporated, effective September 1, 2018. OMLP's application includes a formulaic price cap adjustment.

The OEB issued a Notice of Hearing on August 28, 2018. Union Gas Limited (Union Gas) applied for intervenor status and did not request cost eligibility. No objection was received from OMLP.

Union Gas is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. Union Gas and OEB staff shall request any relevant information and documentation from OMLP that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on OMLP by **October 5, 2018**.
2. OMLP shall file with the OEB complete responses to all interrogatories and serve them on Union Gas by **October 16, 2018**.
3. Unless the OEB orders otherwise, Union Gas and OEB staff may file any written submission with the OEB and serve them on OMLP by **October 30, 2018**.
4. Unless the OEB orders otherwise, OMLP may file a written reply submission with the OEB and serve it on Union Gas by **November 9, 2018**.

All filings to the Board must quote the file number, EB-2018-0234 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
