AFFIDAVIT OF SERVICE AND PUBLICATION

I, Stephanie Allman, of the Town of Keswick, make oath and say as follows:

1. I am in the employ of Enbridge Gas Distribution Inc. ("Enbridge") and as such have knowledge of the matters hereinafter deposed to.
2. Pursuant to the August 21, 2018 Letter of Direction from the Ontario Energy Board (the "OEB" and / or the "Board"), I caused to be served by courier a copy of both the English and French versions of the Notice of Application (Exhibit "A") and Enbridge's Application (Exhibit "B") upon all affected property owners, on all encumbrancers and encumbrances with lands or interest in lands as shown by the Affidavit of Search of Title dated April 2, 2018 (Exhibit "C"). Enbridge's evidence was also served on the above mentioned parties as requested, however, due to the volume of the exhibits they have not been provided as an attachment to my Affidavit.
3. Pursuant to the Letter of Direction, I caused to be served by courier a copy of the English and French versions of the Notice of Application and Enbridge's Application and Evidence on the Clerk for the City of Toronto and on all indigenous communities that have been consulted or with lands or interest in lands directly affected by the propose pipeline.

4. In accordance with the Letter of Direction, attached hereto is proof, in the form of UPS courier confirmation sheets (Exhibit "D") that the relevant Notice of Application, Enbridge's Application and Evidence was served on the above mentioned parties as requested by the Board's in the Letter of Direction.
5. Pursuant to the Letter of Direction, I caused to be served by email a copy of the English and French versions of the Notice of Application and Enbridge's Application the members of the Ontario Pipeline Coordinating Committee (Exhibit "E"). Through correspondence with the OEB Registrar's Office, it was confirmed that the above noted parties do not require receiving a paper copy of the evidence.
6. Pursuant to the Letter of Direction, I caused to be served by courier or email a copy of the English and French versions of the Notice of Application and Enbridge's Application on all affected utilities and pipelines. Enbridge Gas Distribution Inc. has applied for approval to construct approximately 350 metres of natural gas pipeline under the Don River in the City of Toronto.

Learn more. Have your say.

If approved, this project would involve replacing approximately 350 metres of existing extra-high pressure natural gas pipeline located on an aging utility bridge with a new extra-high pressure natural gas pipeline located under the Don River. Enbridge Gas Distribution Inc. says the project is needed to ensure safe and reliable operation of the Don Valley Pipeline.

Enbridge Gas Distribution Inc. is also asking the OEB to approve the form of agreement it offers to landowners to use their land for routing or construction of the proposed line.

A map of the proposed pipeline project is provided below.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Enbridge Gas. During the hearing, we will question Enbridge Gas on the case. We will also hear questions and arguments from individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas' compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

The OEB will also assess whether the duty to consult with Indigenous communities potentially affected by the proposed pipeline has been discharged with respect to the application.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Enbridge Gas on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply **September 12, 2018** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

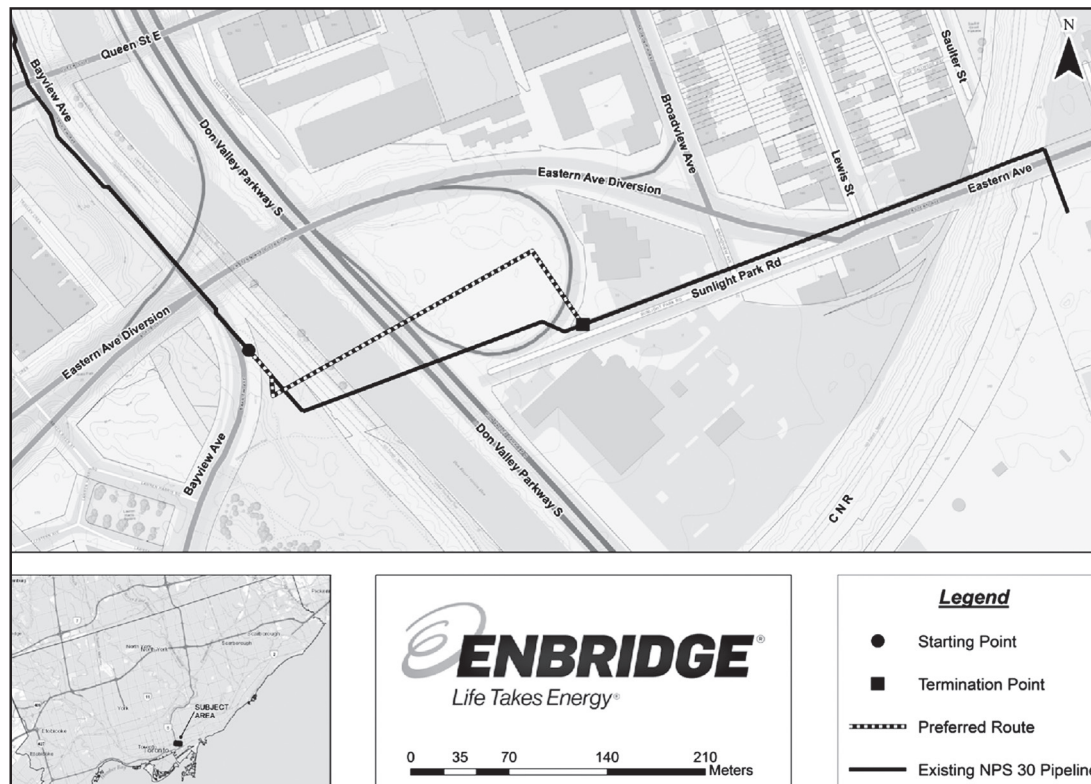
ORAL VS. WRITTEN HEARINGS

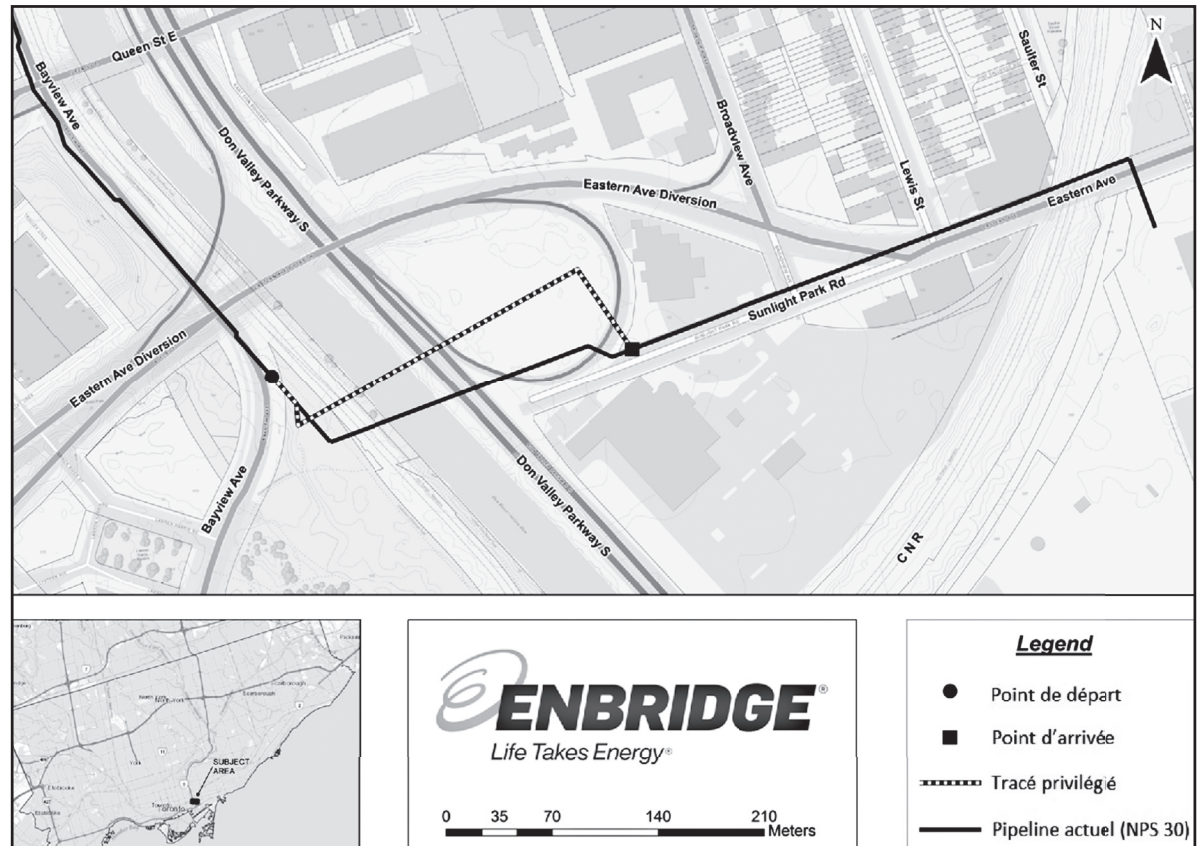

**LEAVE TO CONSTRUCT APPLICATION: DON VALLEY
PIPELINE**

1. The Applicant, Enbridge Gas Distribution Inc. ("Enbridge") is an Ontario corporation with its head office in the City of Toronto. It carries on the business of selling, distributing, transmitting, and storing natural gas within Ontario.
2. Enbridge hereby applies to the Ontario Energy Board (the "Board"), pursuant to Section 90 (1) of the Act, for an Order or granting leave to construct approximately 0.35 kilometres of NPS 30 inch extra high pressure pipeline (the "Project" or "Don Valley Pipeline"). The Project will replace an existing segment of pipeline supplying the City of Toronto, Ontario. /u
3. The segment of pipeline to be replaced is located on an infrastructure bridge (the "Bridge") owned by Enbridge that spans the Don River. Enbridge has determined that the Bridge should be removed and the segment of pipeline

located on the Bridge should be abandoned and replaced as the Bridge poses a risk to the safe operation and reliability of the Don Valley Pipeline.

4. The Don Valley Pipeline is a single source feed located in the densely populated urban area of Toronto. It supplies natural gas to a large population of non-interruptible residential customers, industrial customers and commercial customers and natural gas fired power plants. The Don Valley Pipeline is a critical distribution pipeline that supplies the diverse mix of customers in the downtown core.
5. The Project consists of the installation of approximately 350 meters of NPS 30 /u extra high pressure steel natural gas main underneath the Don River from Bayview Avenue to Sunlight Park Road and the decommissioning of approximately 350 meters of the existing NPS 30 extra high pressure pipe /u segment on the Bridge. A map showing the general location of the proposed pipeline route can be found in Exhibit B, Tab 1, Schedule 1, Attachment 5.
6. The route and location for the proposed facilities associated with the Project were selected by an independent environmental consultant through the process outlined in the Ontario Energy Board's "*Environmental Guidelines for the Location, Construction, and Operation of Hydrocarbon Pipelines and Facilities in Ontario*" (7th Edition, 2016) (the "Guidelines"). Input from the public was sought during the route selection process and was incorporated into the final route decision. Details on the route selection, along with the Environmental Implementation plan, and Environmental and Socio Economic Impact Assessment can be found in the C series of Exhibits.

7. Pursuant to the Guidelines, Enbridge requested that the Ministry of Energy (the “MOE”) determine if there is any Duty to Consult requirements for the Project. The MOE has delegated the procedural aspects of Duty to Consult for the Project to Enbridge. Information on indigenous consultations and Duty to Consult activities can be found at Exhibit F, Tab 1, Schedule 1.
8. Enbridge has included draft agreements in the E series of Exhibits that will be offered to affected landowners where the need for an easements arises.
9. Planning and engineering will occur in 2017 / 2018, with construction to begin in 2019. Enbridge is therefore requesting the Board issue a decision for this proceeding not later than December 2018 in order to meet Project timelines.
10. Enbridge requests this Application proceed by way of written hearing in English.
11. Enbridge requests the Board issue the following Orders:
 - (i) pursuant to section 90 of the *Ontario Energy Board Act*, 1988, S.O., 1988, c-15, Schedule B, an Order granting leave to construct the pipelines.
 - (ii) pursuant to section 97 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c-15, Schedule B, an Order approving the form of easement agreements found at Exhibit E, Tab 1, Schedule 3.
