We are counsel to Hydro One Networks Inc. ("HONI") in the combined proceeding. What follows is our client's position with respect to the confidential treatment of three interrogatory responses, delivered pursuant to Procedural Order No. 7.

We are instructed that our client waives the claim for confidentiality of the response to Exhibit I, Tab 1, Schedule 18.

With respect to Exhibit I, Tab 2, Schedule 24, Attachment 1 and Exhibit I, Tab 5, Schedule 21, our client is prepared, subject to the conditions set out below, to provide unredacted versions of the materials to counsel who sign the required Declaration and Undertaking. Our client is not prepared to provide unredacted versions of the documents to consultants, regardless of whether they sign a Declaration and Undertaking, unless it can be demonstrated that counsel requires the advice of the consultants in order to properly understand the materials.

Our client is not prepared to provide unredacted versions of the documents to employees of parties, regardless of whether they are lawyers and regardless of whether they sign a Declaration and Undertaking. In particular, our client is not prepared to provide an unredacted version of the materials to Mr. Murphy, whom we are advised is an employee of either the applicant, Upper Canada Transmission Inc., or one of its parents or affiliates.

With respect to the provision of unredacted versions of the materials, our client will make the materials available at a time and at a location convenient to counsel, on the understanding that counsel are not to make notes on, make copies of, or take pictures of, the materials.
