Re: East-West Tie

Further to our discussions on the above-referenced project, this letter is to confirm the Crown and Ontario Power Authority (OPA) roles in any duty to consult on the proposed East-West tie project during the period prior to any Ontario Energy Board (Board) transmitter designation.

The Crown has decided to delegate certain procedural aspects of consultation to the OPA since the OPA is establishing the rationale, scope and timing of the East-West tie project and will be submitting a report on the project to the Board by the end of June. We understand that the OPA is already conducting a consultation process on the Integrated Power System Plan (IPSP) which will include all of the Aboriginal communities that may be affected by the East-West tie project. If timing requirements associated with the preparation of the report permit the coordination of discussions on the East-West tie project with IPSP consultations, this approach may facilitate rational use of Crown and Aboriginal community resources.

Crown Role

A list of communities (List) to consult on the East-West tie project has been provided to the OPA previously and is attached. Should the OPA determine that discussions on the East-West tie project can be coordinated with its consultations on the IPSP, the Crown will send letters to the relevant communities indicating that the OPA process for carrying out any duty to consult on the IPSP will include the process through which the Crown consults on the East-West tie project prior to any Board transmitter designation decision.

Ministry officials, as appropriate and required, will accompany OPA staff in meetings on the East-West Tie project.

OPA Role

In meetings with communities on the List, we understand that the OPA will ensure the agenda provides for discussion of the Project and any Board transmitter designation process.

Community representatives should be offered the opportunity to provide input on the Project and the Board's possible designation of a transmitter. Community representatives should also be advised on how to obtain more information from the Board on the transmitter designation process and how they can participate in it.

The OPA will include a record of these discussions in its report on the preliminary assessment of need for the Project, which the Board has requested be submitted no later than June 30th, 2011.

I trust that this reflects our discussions regarding the respective roles of the Ministry and the OPA in addressing any duty to consult on the East-West tie project.

Re: Request for Board Direction to OPA
East-West Tie Designation Proceeding (EB-2011-0140)

The Board has considered your letter dated April 30, 2012, written on behalf of your client Pic River First Nation ("PRFN"). The letter requests that the Board direct the Ontario Power Authority ("OPA") to provide information and verification pertaining to the OPA's consultation activities to date with Aboriginal communities. Your letter indicates that such information had been requested from the OPA on March 29, 2012 and that, as of April 30, 2012, PRFN has not received any documentation from the OPA in response to its request.

Effective consultation is critical to the success of the development of the East - West Tie line. The Board agrees that a record of the OPA's Aboriginal consultation activities to date would be useful information for the record of this proceeding at this time, in that it can inform parties' submissions on the issues and filing requirements associated with consultation and the preparation of plans for consultation. However, the question of whether the OPA's consultation to date has been sufficient is not before the Board.

Your letter also requests the production of any "advice of the Crown that the OPA's consultation activities were completed". It is not clear to the Board that this "advice" exists. If the OPA has received such advice, it would be helpful to confirm this as part of the May 7 filing directed by this letter.

In conclusion, for the reasons stated above, the Board directs the OPA to file with the Board, as part of a submission or otherwise, a record of its Aboriginal consultation activities to date, regarding the East-West Tie line project, with copies to all intervenors in this proceeding, by May 7, 2012. This filing should include an explanation of the nature of the consultation activities carried out (e.g. meetings, letters) and feedback received from the communities consulted.

All parties will have a chance to respond to the OPA's submission, as well as other parties' submissions by May 16, 2012, as per the directions in Procedural Order 2.

I am writing in response to your letter of May 2, 2012 in which the Ontario Power Authority ("OPA") was directed to file:

- a record of its Aboriginal consultation activities to date, regarding the East-West Tie line project, with copies to all intervenors;
- an explanation of the nature of consultation activities carried out and the feedback from the communities consulted.

On May 4, 2012, the OPA requested that the submission date be extended to May 11, 2012.

On May 31, 2011, the Ministry of Energy delegated certain procedural aspects of any duty to consult on the East-West Tie line project to the OPA prior to any Board transmitter designation. The Ministry directed the OPA to consult with identified First Nation and Métis communities regarding its planning work in establishing the rationale, scope and timing of the East-West Tie line project. The Ministry also directed the OPA to include a record of its discussions with First Nations and Métis communities in its preliminary assessment report to the OEB by June 30, 2011. The OPA's consultation does not preclude project level consultation which may be delegated to the designated transmitter by the Crown.

The OPA worked closely with the Ministry in carrying out consultation activities. Representatives of the Ministry were directly involved in regional sessions and some community meetings and were provided frequent status updates on these activities. The OPA's preliminary assessment report was shared with the Ministry, and reflected a record of discussions with First Nations and Métis communities. The OEB asked in its

letter of May 2, 2012 for the OPA to confirm if "advice" from the Crown existed. There is no written record of such "advice", however, the Crown did not express any concerns with respect to the activities undertaken by the OPA on its behalf.

The activities undertaken by the OPA on behalf of the Crown with respect to the East-West Tie line project include the following:

- Information about the East-West Tie process was shared by the Ministry of Energy with each of the identified First Nation and Métis communities;
- Regional sessions in Toronto, Sudbury and Thunder Bay on the Integrated Power System Plan included a distinct agenda item to provide the identified First Nation communities an opportunity to receive information and provide feedback regarding the rationale, scope, and timing of the East-West Tie line project and the OEB's designation process;
- Community meetings were offered to First Nation and Métis communities that were identified by the Crown to discuss the East-West Tie line project, including the rationale, scope, and timing, as well as the OEB's designation process; and
- The draft report was shared with all identified First Nation and Métis communities with an additional opportunity to provide written submissions on the OPA's findings as they relate to the rationale, scope and timing of the East-West Tie line project, along with any Aboriginal interests as documented in the draft report.

The attached record of activities undertaken by the OPA demonstrates its efforts to ensure that each of the identified communities was provided with the information and the opportunity to raise interests or concerns in respect of the East-West Tie line project. While not all communities participated in regional sessions or community meetings, each community was provided several opportunities to receive information and provide feedback to the OPA.

The OPA's report on the project, entitled *The Long Term Electricity Outlook for the Northwest and Context for the East-West Tie Expansion*, noted that the interests or concerns raised by First Nation and Métis communities through the consultation sessions were linked to the cost of the project and the importance of beginning consultation early in the project development phase. The OPA heard that it is important to consider potential project costs that may relate to Aboriginal participation in the transmission project and any accommodation of Aboriginal or treaty rights. These points were reiterated directly to the Board during the session for interveners and transmitters on March 23, 2012.
