Application for Leave to Construct Transmission Facilities in the District of Sudbury, Ontario

PROCEDURAL ORDER NO. 1

October 4, 2018

On July 11, 2018, 2018, IAMGOLD Corporation (IAMGOLD) applied to the Ontario Energy Board (OEB) under sections 92, 97 and 101 of the *Ontario Energy Board Act, 1998* for an order granting leave to construct approximately 44 kilometres of 115 kV transmission line and associated facilities in the District of Sudbury, Ontario. On August 14, 2018, IAMGOLD updated its original evidence to include the Customer Impact Assessment.

The OEB issued a Notice of Hearing on September 7, 2018. Each of Independent Electricity System Operator (IESO) and Mattagami First Nation applied for intervenor status. Mattagami First Nation also applied for cost eligibility.

No objection was received from IAMGOLD.

IESO and Mattagami First Nation are approved as intervenors. The list of parties in this proceeding is attached as Schedule A to this Procedural Order. Mattagami First Nation is eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards*.

Parties are reminded that as required by the *Ontario Energy Board Act* the OEB will consider three issues:

- The interests of consumers with respect to prices and the reliability and quality of electricity service;
- The promotion of the use of renewable energy sources in a manner consistent with the policies of the Government of Ontario; and
- The form of agreement that IAMGOLD offers to landowners affected by the transmission line and associated facilities.

The OEB's review will only address the three factors outlined above and will not address other factors, such as, environmental, health, aesthetics or property value impacts.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- 1. Intervenors and OEB staff shall request any relevant information and documentation from IAMGOLD that is in addition to the evidence already filed, by written interrogatories filed with the OEB by **October 17, 2018**.
- 2. IAMGOLD shall file with the OEB complete responses to all interrogatories by **October 29, 2018.**
- 3. Unless the OEB orders otherwise, intervenors and OEB staff may file any written submission with the OEB and serve them on IAMGOLD by **November 8, 2018**.
- 4. Unless the OEB orders otherwise, IAMGOLD may file a written reply submission with the OEB and serve them on intervenors by **November 19, 2018**.

All filings to the Board must quote the file number, EB-2018-0191 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at https://pes.ontarioenergyboard.ca/eservice/. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at https://www.oeb.ca/industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies.
