**Oakville Hydro Electricity Distribution Inc.**

**Application for electricity distribution rates effective  
January 1, 2019**

**PROCEDURAL ORDER NO. 1  
October 9, 2018**

Oakville Hydro Electricity Distribution Inc. (Oakville Hydro) filed an application with the Ontario Energy Board (OEB) on September 12, 2018 for rates pursuant to the OEB's Price Cap IR framework and for the recovery of costs incurred to restore power to customers affected by a windstorm in May 2018 (Z factor). The application was filed under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Incentive Regulation Rate Applications seeking approval for changes to Oakville Hydro's electricity distribution rates to be effective January 1, 2019.

The OEB issued a Notice of Hearing on September 5, 2018. No parties or persons applied for intervenor status or cost eligibility.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

**IT IS THEREFORE ORDERED THAT:**

1. OEB staff shall request any information and material from Oakville Hydro that is in addition to Oakville Hydro's evidence and that is relevant to the hearing by

written interrogatories filed with the OEB and delivered to Oakville Hydro by **October 19, 2018**.

2. Oakville Hydro shall file with the OEB complete written responses to the interrogatories by **November 2, 2018**.
3. Unless the OEB orders otherwise, any written submission by OEB staff shall be filed with the OEB and delivered to Oakville Hydro by **November 16, 2018**.
4. Unless the OEB orders otherwise, Oakville Hydro may file a written reply submission with the OEB by **November 23, 2018**.

All filings to the OEB must quote the file number, EB-2018-0059 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below.
