Re: Energy+ Inc. ("Energy+") 2019 Cost of Service Application; Board File No. EB-2018-0028; Revised Evidence of J. Pollock

We are writing on behalf of Toyota Motor Manufacturing Canada Inc. ("TMMC") to file the Written Evidence of Jeffry Pollock, revised to correct certain inadvertent errors (the "Revised Pollock Evidence"). The pages that have been revised are indicated as "Revised" in the page header and the actual revisions are shaded in grey.

The Revised Pollock Evidence includes information related to TMMC's consumption of electricity at its Cambridge assembly plant. This information is commercially sensitive and, thus, confidential for the reasons set out in our letter of September 27, 2018. The confidential information has been redacted from the Revised Pollock Evidence that has been filed through RESS today.

In accordance with the Ontario Energy Board's ("Board") Practice Direction on Confidential Filings ("Practice Direction"), TMMC is delivering to the offices of the Board, a sealed envelope marked "Confidential" that includes: (i) two hard copies of the unredacted, confidential revised pages of the Written Evidence of Jeffry Pollock; and (ii) a USB key with the unredacted, confidential excel version of Schedule JP-5 to the Revised Pollock Evidence. The confidential revised pages of the unredacted evidence are marked as "Confidential" at the top of each page and the confidential portions of that page are indicated. Where the whole page is confidential, it is printed on yellow paper.

The disclosure of the confidential information in the Revised Pollock Evidence and in the electronic version of Schedule JP-5 (together, the "Confidential Information") could adversely affect the economic and/or competitive interests of TMMC. Accordingly, TMMC requests that the Confidential Information be held in confidence and not included in the public record of this proceeding. TMMC is prepared to provide unredacted copies of the Revised Pollock Evidence and the excel version of Schedule JP-5 to parties' counsel, external experts, consultants or others who have executed the Board's form of Declaration and Undertaking under the Practice Direction. TMMC reserves the right to object to the Board's acceptance of a Declaration and Undertaking from any person.
