# Application for leave to transfer EPCOR Southern Bruce Gas Inc.'s certificates of public convenience and necessity to EPCOR Natural Gas Limited Partnership

# **PROCEDURAL ORDER NO. 1**

October 25, 2018

On August 10, 2018, EPCOR Southern Bruce Gas Inc. (EPCOR Inc.), EPCOR Natural Gas Limited Partnership (EPCOR LP) and EPCOR Utilities Inc. applied to the Ontario Energy Board (OEB) under section 18 of the *Ontario Energy Board Act, 1998* and section 8 of the *Municipal Franchises Act, 1990* for an order granting leave to transfer EPCOR Inc.'s certificates of public convenience and necessity to EPCOR LP.

The OEB issued a Notice of Hearing on September 21, 2018. The last date for intervention was October 15, 2018. Union Gas Limited (Union Gas) applied for intervenor status. No objection was received from the applicants.

Union Gas is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

## IT IS THEREFORE ORDERED THAT:

- 1. Union Gas and OEB staff may file any written submission with the OEB and serve them on the applicants on or before **October 31, 2018**.
- 2. Unless the OEB orders otherwise, the applicants may file a written reply submission with the OEB and serve it on Union Gas by **November 6, 2018**.

All filings to the Board must quote the file number, EB-2018-0247 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <u>https://pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>https://www.oeb.ca/industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies.
