**Application for certificate of public convenience and necessity to
construct works to supply natural gas in the
unincorporated Township of Ledger**

PROCEDURAL ORDER NO. 1

October 31, 2018

On August 10, 2018, Nipigon LNG Corporation, the general partner of and on behalf of Nipigon LNG LP, applied to the Ontario Energy Board (OEB) under section 8 of the *Municipal Franchises Act, 1990* for an order approving a certificate of public convenience and necessity to construct works to supply natural gas in the unincorporated Township of Ledger.

The OEB issued a Notice of Hearing on October 12, 2018. The last date for intervention was October 26, 2018. Union Gas Limited (Union Gas) and TransCanada PipeLines Limited (TransCanada) applied for intervenor status. No objection was received from the applicants.

Union Gas and TransCanada are approved as intervenors. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. Parties shall request any relevant information and documentation from the applicants that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on the applicants by **November 2, 2018**.

2. The applicants shall file with the OEB complete responses to all interrogatories and serve them on all parties by **November 6, 2018**.
3. Unless the OEB orders otherwise, parties may file any written submission with the OEB and serve them on the applicants by **November 9, 2018**.
4. Unless the OEB orders otherwise, the applicants may file a written reply submission with the OEB and serve it on all parties by **November 14, 2018**.

All filings to the Board must quote the file number, EB-2018-0248 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
