Hydro One Networks Inc.

Application for permission to upgrade existing transmission facilities in the City of Timmins and the District of Sudbury, Ontario

PROCEDURAL ORDER NO. 1

December 6, 2018

On August 30, 2018, Hydro One Networks Inc. (Hydro One) applied to the Ontario Energy Board (OEB) under sections 92 and 97 of the *Ontario Energy Board Act, 1998* for permission to upgrade one circuit of a 115 kilometre idle 115 kilovolt electricity transmission line and associated station facilities from Timmins Transformer Station to Shiningtree Junction. These upgrades will supply IAMGOLD's Côté Mine facility located approximately 20 km southwest of Gogama, Ontario.

The OEB issued a Notice of Hearing on November 12, 2018. The Independent Electricity System Operator (IESO) applied for intervenor status. No objection was received from Hydro One. IESO is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- IESO and OEB staff shall request any relevant information and documentation from HONI that is in addition to the evidence already filed, by written interrogatories filed with the OEB and delivered to HONI by **December 17, 2018**.
- 2. HONI shall file with the OEB complete responses to all interrogatories and deliver them to IESO by **January 18, 2019.**
- 3. Unless the OEB orders otherwise, IESO and OEB staff may file any written submission with the OEB and serve them on HONI by **January 30, 2019**.

4. Unless the OEB orders otherwise, HONI may file a written reply submission with the OEB and serve them on IESO by **February 12, 2019**.

All filings to the Board must quote the file number, EB-2018-0257 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at https://pes.ontarioenergyboard.ca/eservice/. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at https://www.oeb.ca/industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
