Application for Leave to Construct Transmission Facilities in the District of Sudbury, Ontario

PROCEDURAL ORDER NO. 2

December 28, 2018

On July 11, 2018, IAMGOLD Corporation (IAMGOLD) applied to the Ontario Energy Board (OEB) under sections 92, 97 and 101 of the *Ontario Energy Board Act, 1998* for an order granting leave to construct approximately 44 kilometres of 115 kV transmission line and associated facilities in the District of Sudbury, Ontario.

The OEB issued a Notice of Hearing on September 7, 2018.

The OEB issued Procedural Order No. 1 (PO No. 1) on October 9, 2018, in which it approved each of the Independent Electricity System Operator (IESO) and Mattagami First Nation (MFN) as intervenors, and deemed MFN eligible for an award of costs. PO#1 also set out timelines for interrogatories and submissions in this proceeding.

In accordance with PO No. 1, MFN submitted interrogatories on October 17, 2018, and filed a submission on November 8, 2018.

The OEB issued its Decision and Order in this proceeding on December 6, 2018. The Decision and Order set a deadline of December 13, 2018 for the filing of the MFN cost claim, but MFN did not submit its cost claim until December 21, 2018. In light of MFN's active participation in the proceeding, the OEB will accept MFN's late filing of its cost claim, but considers it appropriate to adjust the deadline for IAMGOLD's filing of a response, if any, to the MFN cost claim.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- 1. IAMGOLD shall file with the OEB and forward to MFN any objections to the claimed costs on or before **January 9, 2019**.
- If IAMGOLD objects to the MFN's costs, MFN shall file with the OEB and forward to IAMGOLD its reply, if any, to any IAMGOLD objection on or before January 16, 2019.

All filings to the Board must quote the file number, EB-2018-0191 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <u>https://pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>https://www.oeb.ca/industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies.
