Union Gas Limited

**Application for leave to construct a natural gas transmission pipeline
and associated facilities in the Counties of Oxford and Perth**

PROCEDURAL ORDER NO. 1

January 2, 2019

Union Gas Limited (Union Gas) applied to the Ontario Energy Board (OEB) under sections 90(1) and 97 of the *Ontario Energy Board Act, 1998* for leave to construct approximately 10.8 kilometres of natural gas transmission pipeline in the Counties of Oxford and Perth and approval of the form of temporary land use agreement related to the construction of the proposed pipeline.

The OEB issued a Notice of Hearing on December 4, 2018. Each of Industrial Gas Users Association (IGUA) and School Energy Coalition (SEC), applied for intervenor status and cost eligibility. No objection was received from Union Gas.

IGUA and SEC are approved as intervenors and are eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards*. The list of parties in this proceeding is attached as Schedule A to this procedural order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and intervenors shall request any information and material from Union Gas that is in addition to Union Gas' evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Union Gas and the intervenors by **January 16, 2019**.

2. Union Gas shall file with the OEB and deliver to the intervenors complete written responses to all interrogatories by **January 30, 2019**.
3. Unless the OEB orders otherwise, OEB staff and intervenors may file any written submission with the OEB and serve them on the applicants by **February 13, 2019**.
4. Unless the OEB orders otherwise, Union Gas may file a written reply submission with the OEB and serve it on all parties by **February 27, 2019**.

All filings to the Board must quote the file number, EB-2018-0306 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.oeb.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB flash drive in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
