The engineered incentive amount of \$15,913.20 is calculated by multiplying 318,264.00 kWh(L) by \$0.05/kWh. HPS were replaced with LED's to achieve energy savings. Due diligence efforts focused on ensuring adequate support for the assumptions used to validate the engineered track kW's and kWh's saved. Manufacturer specification sheets were referenced to confirm values entered into engineered calculator sheets.


