Decision and Order

NextEra Energy Canadian Operating Services, Inc. (NextEra) filed an application dated August 22, 2018, with the Ontario Energy Board (OEB), under section 74 of the *Ontario Energy Board Act, 1998* (OEB Act) to amend its electricity generation licence EG-2012-0311. The application was deemed complete on December 19, 2018.

Cedar Point II Limited Partnership (Cedar) filed a separate but related application with the OEB dated December 19, 2018, under section 74 of the OEB Act to amend its electricity generation licence EG-2015-0137.

The OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act.

Cedar is the current owner and operator of Cedar Point II wind generation facility (Cedar Point II) with an installed capacity of 100 MW under the Feed-in Tariff (FIT) contract with the Independent Electricity System Operator (IESO). Cedar requested an amendment to amend Schedule 1 of its electricity generation licence EG-2015-0137 such that it will no longer be listed as the operator of Cedar Point II.

NextEra requested to amend Schedule 1 of its electricity generation licence EG-2012-0311 to become the operator of Cedar Point II. NextEra under licence EG-2012-0311 is listed as the operator of 12 renewable generation facilities (wind and solar) operated under the FIT contract with the IESO under the authority of its existing licence EG-2012-0311.

NextEra and Cedar (collectively, applicants) agreed on this authorization change. The applicants also stated that there is no effect of this change on the existing FIT contracts and all other provisions remain the same.

This Decision and Order is being issued by the Delegated Authority, without holding a hearing, pursuant to Section 6(4) of the OEB Act. After considering the application, the OEB finds it to be in the public interest to grant the applications and amend the licences of Next Era and Cedar.

IT IS ORDERED THAT:

1. Schedule 1 of NextEra Energy Canadian Operating Services, Inc.'s electricity generation licence EG-2012-0311 is amended in accordance with the attached revised licence.
2. Schedule 1 of Cedar Point II Limited Partnership's electricity generation licence EG-2015-0137 is amended in accordance with the attached revised licence.
