IN THE MATTER OF the Ontario Energy Board Act, 1998, S.O. 1998, c.15 (Sched. B);

AND IN THE MATTER OF an Application by Enbridge Gas Distribution Inc. and Union Gas Limited, pursuant to section 36(1) of the *Ontario Energy Board Act, 1998*, for an order or orders approving or fixing just and reasonable rates and other charges for the sale, distribution, transmission and storage of gas as of January 1, 2019.

- AFFIDAVIT OF SERVICE -

I, Nancy Standard, of the Municipality of Chatham-Kent, in the Province of Ontario, MAKE OATH AND SAY:

1. That I am employed by Enbridge Gas Inc. in the position of Administrative Assistant, Regulatory Affairs.

SERVICE ALERT :
As a result of damage to a gas line, there are approximately 550 customers without gas service in the Ottawa area. These streets in the Blackburn Hamlet/Innes Park area are affected:

AUTUMN HILL CRES; BRAEBURN PL; FALKIRK CRES; GARDEN PARK LANE; GREENWAY PK; KELDEN CRES; ORIENT PARK DR; RONDEL ST

At this time, crews are working on repairs. Technicians will need to visit each home to ensure the gas service is safely turned off, and then again to reconnect service once the repairs are complete and the system has been tested.

We anticipate that this process could take up to 24 hours. As always, our focus is on the safety of our employees and the public.

Here's what you can do/expect:

- Wait - our technicians will be going door to door and will need access to your natural gas appliances. All Enbridge representatives carry photo identification.
- Customer Care will send an automated message to the phone number we have on file.
- If you are not home when we visit, call the phone number on the notice or our Customer Care centre at 1-877-362-7434.
- As always, if you smell natural gas, please call our emergency number at 1-866-763-5427.
