NOTICE OF HEARING AND PROCEDURAL ORDER NO. 1

February 13, 2019

On October 25, 2018, the Association of Major Power Consumers of Ontario (AMPCO) filed a Notice of Motion to review and vary the Decision and Order on Cost Awards in relation to a motion to review and vary the Decision and Order on the Ontario Power Generation Inc. (OPG) 2017-2021 payment amounts¹. AMPCO requests that the Ontario Energy Board (OEB) amend its Cost Decision and allow recovery by AMPCO of a further 0.6 hours of counsel's time for review of the OPG Motion Decision and applicable HST. The OEB has assigned this motion file number EB-2018-0304.

Under Rule 43.01 of the OEB's *Rules of Practice and Procedure*, the OEB may determine, with or without a hearing, a threshold question of whether the matter should be reviewed before conducting any review on the merits of the motion. The OEB has determined that it will consider the merits of the motion at this time. The OEB has also determined it will hear the motion in writing.

In the Motion to Review, AMPCO stated that it is not seeking recovery of incurred costs of this motion. The OEB does not intend to award costs of this motion to any other intervenors who may wish to make submissions.

The OEB considers it necessary to make provisions for the following procedural matters related to the motion.

IT IS THEREFORE ORDERED THAT:

- 1. AMPCO may file additional material in support of its motion relating to the merits of the motion by **February 25, 2019**. The material shall be filed with the OEB and copied to all parties of the record in the EB-2018-0085 proceeding.
- 2. OPG, Intervenors in EB-2018-0085 and OEB staff may file a written submission on the merits of the motion by **March 8, 2019**. The submission shall be filed with the OEB and copied to all parties of the record in the EB-2018-0085 proceeding.
- 3. AMPCO may file a written reply submission by **March 15, 2019**. The reply submission shall be filed with the OEB and copied to all parties of record in the EB-2018-0085 proceeding.

All filings to the OEB must quote the file number, **EB-2018-0304**, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <u>https://pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>http://www.oeb.ca/Industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a USB stick in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
