The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Enbridge Gas Inc.'s (formerly Enbridge Gas Distribution Inc. and Union Gas Limited) 2019 Federal Carbon Pricing Program application (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's agent, which were copied to you. Please note that you must comply with the directions in paragraphs 1 to 2 below **prior to March 3, 2019**, which is the publication date of the newspaper in which the Notice will appear last.  - ii. The band councils of all Indigenous communities and First Nation Reserves to which Enbridge Gas Inc. supplies gas
 - iii. The Métis Nation of Ontario
 - iv. Intervenors in Union Gas Limited's 2018 Cap-and-Trade Compliance Plan proceeding, EB-2017-0255

- v. Intervenors in Enbridge Gas Distribution Inc.'s 2018 Cap-and-Trade Compliance Plan proceeding, EB-2017-0224
 - vi. Intervenors in Union Gas Limited's 2018 rate proceeding EB-2017-0087
 - vii. Intervenors in Enbridge Gas Distribution Inc.'s 2018 rate proceeding EB-2017-0086
 - viii. The Ontario Ministry of Energy, Northern Development and Mines
 - ix. The Ontario Ministry of the Environment, Conservation and Parks
 - x. Environment and Climate Change Canada
2. To make a copy of both the English and French versions of the Notice, the application and evidence, and any amendments thereto, available for public review at Enbridge Gas Inc.'s Toronto and Chatham office and in a prominent place on each of the websites of Enbridge Gas Distribution (enbridgegas.com) and Union Gas Limited (uniongas.com).
 3. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 2 above immediately thereafter.
 4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.
 5. From this date onward, to use only Ontario Energy Board File Number EB-2018-0205 for all documents filed this proceeding.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
