Re: Energy+ Inc. ("Energy+") 2019 Cost of Service Application;

Board File No. EB-2018-0028; Updated Evidence of Jeffry Pollock and Updated Responses to Technical Conference Interrogatories; Request for Confidentiality

We are writing on behalf of Toyota Motor Manufacturing Canada Inc. ("TMMC") and in accordance with Procedural Order No. 7 to file in a sealed envelope marked "Confidential": (i) two hard copies of the unredacted Updated Written Evidence of Jeffry Pollock ("Updated Evidence"); and (ii) a USB key with the unredacted, password-protected Updated Evidence and related schedules with live Excel Worksheets. We are also filing updates to TMMC's previous responses to Technical Conference Interrogatories ("Updated IR Responses") as follows: Energy Plus-TMMC-TC2-4 and TC8-10; Schools Energy Coalition SEC-TMMC-TC2; and OEB Staff-TMMC-TC1.

The confidential pages of the unredacted versions of the Updated Evidence are marked as "Confidential" at the top of each page and the confidential portions of that page are delineated by yellow highlighting. Where the whole page is confidential, it is printed on yellow paper. Redacted versions of the Updated Evidence as well as the Updated IR Responses have been filed, through RESS. Unredacted, confidential copies of the Updated Evidence have been provided to all parties who have signed the requisite Declaration and Undertaking.

The confidential portions of the Updated Evidence include commercially sensitive information related to TMMC's consumption of electricity at its Cambridge assembly plant. The public disclosure of this information would adversely affect the economic and/or competitive interests of TMMC, potentially resulting in undue financial harm. Accordingly, similar to TMMC's previous requests for confidential treatment in this proceeding, TMMC requests that the Updated Evidence be held in confidence and not included in the public record of this proceeding.
