 - f. Proposed disposition of various deferral and variance accounts; and
 - g. Generally to represent the interests of school boards and their students in this process.

4. SEC intends to participate in any pre-hearing procedures, including interrogatories or technical conferences, and settlement conferences. SEC also intends to participate in any oral

hearing of this matter, and in written or oral submissions, as well as any other parts of the process that the Board should order.
