Re: Atikokan Hydro Inc. 2019 IRM Distribution Rate Application OEB File NO. EB-2018-0018 Draft Decision and Rate Order

Atikokan Hydro has reviewed the Draft Decision and Rate Order issued February 26, 2019 for rates and other charges for electricity distribution effective May 1, 2019 and confirms the completeness and accuracy of Schedule A; Tariff of Rates and Charges.

Atikokan did note one typographical error but it does not affect the Schedule A: Tariff of Rates and Charges. The Group 1 accounts total of (51,143) is correct. The error is in the IRM Model and correspondingly Table 6.2: Group 1 Deferral and Variance Account Balances. Atikokan has no dollars to report in LV Variance Account 1550. SME Charge Variance Account 1551 should read a principal disposition of 96 during 2018; thereby with a closing principal balance of 76. Atikokan Hydro is submitting the revised IRM Model and a revised Table 6.2 with the Group 1 Deferral and Variance Account Balances.
