NOTICE OF APPLICATION FOR INTERVENOR STATUS**

1. Integrated Grain Processors Co-operative Inc. and IGPC Ethanol Inc. (together, "IGPC") hereby apply for intervenor status in this proceeding.
2. IGPC owns and operates an ethanol facility in the Town of Aylmer. There are more than 700 members, farmers and individual members of the local community that comprise IGPC. IGPC employs more than 65 employees. The ethanol facility has recently completed an expansion that will increase the need for natural gas during the fall of 2018 and beyond.
3. IGPC is the largest customer of the Applicant, EPCOR Natural Gas Limited Partnership ("EPCOR"), and therefore is directly impacted by this Application. IGPC is the sole customer in EPCOR's Rate 6 class.
4. IGPC reserves its rights to file interrogatories, file evidence, cross-examine witnesses, make submissions and otherwise fully participate in this proceeding. At this time, IGPC does not take a position as to whether an oral hearing is necessary and suggest such a determination should be made following interrogatories and any settlement conference.

5. IGPC will not be seeking a cost award.
