# **ENWIN UTILITIES LTD.**

Application for rates and other charges to be effective May 1, 2019

By Delegation, Before: Theodore Antonopoulos

March 28, 2019

## 1 INTRODUCTION AND SUMMARY

Through this Decision and Order, the Ontario Energy Board (OEB) approves the incentive rate-setting mechanism (IRM) application filed by ENWIN Utilities Ltd. (ENWIN Utilities) on September 21, 2018, as amended during the course of the proceeding.

ENWIN Utilities serves about 88,000 mostly residential and commercial electricity customers in the City of Windsor. The company is seeking the OEB's approval for the rates it charges to distribute electricity to its customers, as is required of licenced and rate-regulated distributors in Ontario.

A distributor may choose one of three rate-setting methodologies approved by the OEB. Each of these is explained in the OEB's <u>Chapter 3 Filing Requirements for Incentive Rate-Setting Applications</u> (Filing Requirements).

ENWIN Utilities' application is based on the Annual IR Index option to set rates for 2019. The Annual IR Index is based on inflation less the OEB's highest stretch factor assessment of a distributor's efficiency. In accordance with the OEB-approved 2019 parameters for an Annual IR Index adjustment, ENWIN Utilities applied for an increase of 0.90% to distribution rates.

As a result of the OEB's findings in this Decision, there will be a monthly total bill decrease before taxes of \$0.09 for a residential customer consuming 750 kWh, effective May 1, 2019.

ENWIN Utilities has also applied to change the composition of its distribution service rates. Residential distribution service rates currently include a fixed monthly charge and a variable usage charge. In 2015, the OEB issued a policy to transition these rates to a fully fixed structure over a four-year period beginning in 2016. Accordingly, in 2019 the final upward adjustment, exceeding the mechanistic adjustment alone, in this Decision has been made and now the distribution rates have transitioned to a fully fixed structure. There is no longer a variable usage rate for this class of customer. This policy change does not affect the total revenue that distributors collect from residential customers.

## **2 THE PROCESS**

This Decision is being issued by delegated authority, without a hearing, under section 6 of the *Ontario Energy Board Act*, 1998 (the OEB Act).

The OEB follows a standardized and streamlined process for IRM applications filed under the Annual IR Index option. In each adjustment year of an Annual IR Index term, the OEB prepares a Rate Generator Model that includes information from the distributor's past proceedings and annual reporting requirements. A distributor will then review and complete the Rate Generator Model and include it with its application.

During the course of the proceeding, the Rate Generator Model will also be updated or corrected, as required. The Rate Generator Model updates base rates, retail transmission service rates and, if applicable, shared tax saving adjustments. It also calculates rate riders for the disposition of deferral and variance account balances.

ENWIN Utilities filed its application on September 21, 2018, under section 78 of the OEB Act and in accordance with the Filing Requirements. ENWIN Utilities supported its application with written evidence and a completed Rate Generator Model. Questions were asked of, and answers were provided by, ENWIN Utilities through emails and phone calls with the OEB. Based on this information, a draft decision was prepared and provided to ENWIN Utilities on February 11, 2019. ENWIN Utilities was given the opportunity to provide its comments on the draft for consideration prior to the OEB issuing this Decision.

# 3 ORGANIZATION OF THE DECISION

In this Decision, the OEB addresses the following issues and provides reasons for approving or denying ENWIN Utilities' proposals relating to each of them:

- Price Cap Adjustment
- Shared Tax Adjustments
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Residential Rate Design

In the final section, the OEB addresses the steps to implement the final rates that flow from this Decision.

This Decision does not address rates and charges approved by the OEB in previous proceedings which are not part of the scope of an IRM proceeding (such as specific service charges<sup>2</sup> and loss factors). No further approvals are required to continue to include these items on a distributor's Tariff of Rates and Charges.

## 4 PRICE CAP ADJUSTMENT

ENWIN Utilities seeks to increase its rates, effective May 1, 2019, based on a mechanistic rate adjustment using the OEB-approved *inflation minus X-factor* formula applicable to Annual IR Index applications.

The components of the Annual Index IR adjustment formula applicable to ENWIN Utilities are set out in Table 4.1, below. Inserting these components into the formula results in a 0.90% increase to ENWIN Utilities' rates: 0.90% = 1.50% - (0.00% + 0.60%).

Table 4.1: Annual IR Index Adjustment Formula

The inflation factor of 1.50% applies to all Annual IR Index applications for the 2019 rate year.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that will vary among different groupings of distributors. Subtracting

the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income.

The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all Annual IR Index applications for the 2019 rate year.

The OEB has established five stretch factor groupings, each within a range from 0.00% to 0.60%. The stretch factor assigned to any particular distributor is based on the distributor's total cost performance as benchmarked against other distributors in Ontario. The most efficient distributor would be assigned the lowest stretch factor of 0.00%. Conversely, a higher stretch factor would be applied to a less efficient distributor (in accordance with its cost performance relative to expected levels) to reflect the incremental productivity gains that the distributor is expected to achieve. For Annual IR Index applications, the OEB applies a default stretch factor of 0.60%.

## **Findings**

The OEB finds that ENWIN Utilities' request for a 0.90% rate adjustment is in accordance with the annually updated parameters set by the OEB. The adjustment is approved, and ENWIN Utilities' new rates shall be effective May 1, 2019.

The adjustment applies to distribution rates (fixed and variable charges) uniformly across all customer classes.<sup>6</sup>

# 5 SHARED TAX ADJUSTMENTS

In any adjustment year of an Annual IR Index term, a change in legislation may result in a change to the amount of taxes payable by a distributor. For IRM applications, the OEB has long held that a 50/50 sharing of the impact of legislated tax changes between shareholders and ratepayers is appropriate in these situations. The shared tax change amount, whether in the form of a credit or a debit, will be assigned to customer rate classes in the same proportions as the OEB-approved distribution revenue by rate class

from a distributor's last cost of service proceeding.

The application identifies a \$647,405 reduction in the amount of taxes payable by ENWIN Utilities in the 2019 rate year. Therefore, an amount of \$323,702 is to be refunded to rate payers.

ENWIN Utilities is proposing an eight-month disposition period for its tax change rate riders to align with its intended 2020 cost of service application seeking rates to be in effect January 1, 2020.

## **Findings**

The OEB approves the tax refund of \$323,702.

The amount shall be disposed through a fixed monthly rate rider for Residential, Unmetered Scattered Load, Sentinel Lighting and Street Lighting customers, and through riders calculated on a volumetric basis for all other customers over an eightmonth period from May 1, 2019 to December 31, 2019.

## **6 RETAIL TRANSMISSION SERVICE RATES**

Distributors charge retail transmission service rates (RTSRs) to their customers to recover the amounts they pay to a transmitter, a host distributor or both for transmission services. All transmitters charge Uniform Transmission Rates (UTRs) approved by the OEB to distributors connected to the transmission system. Host distributors charge host-RTSRs to distributors embedded within the host's distribution system.

ENWIN Utilities is transmission connected and is requesting approval to adjust the RTSRs that it charges its customers to reflect the rates that it pays for transmission services included in Table 6.1.

## **Findings**

ENWIN Utilities' proposed adjustment to its RTSRs is approved. The RTSRs were adjusted based on the UTRs current at the time of the filing. The OEB finds that the new 2019 UTRs are to be incorporated into the rate model to adjust the RTSRs that ENWIN Utilities will charge its customers accordingly.

## 7 GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts in order to determine whether their total balance should be disposed. OEB policy requires that Group 1 accounts be disposed if they exceed (as a debit or credit) a pre-set disposition threshold of \$0.001 per kWh, unless a distributor justifies why balances should not be disposed. If the balance does not exceed the threshold, a distributor may elect to request disposition.

The 2017 actual year-end total balance for ENWIN Utilities' Group 1 accounts including interest projected to April 30, 2019 is a credit of \$712,389. This amount represents a total credit claim of \$0.0003 per kWh, which does not exceed the disposition threshold. In its application, ENWIN Utilities states that although the disposition threshold for Group 1 deferral and variance accounts has not been exceeded, the total Group 1 account

balance excluding the Global Adjustment (GA) account is a material credit balance of \$1,619,836 to be returned to all of ENWIN Utilities' customers. In addition, the GA account is a material debit balance of \$907,447 which will be recovered from another group of customers: Class B non-Regulated Price Plan (RPP) customers. ENWIN Utilities proposes the disposition of its Group 1 accounts over an eight-month period to align with its intended 2020 cost of service application seeking rates to be in effect for January 1, 2020.

As stated in the previous paragraph, included in the balance of the Group 1 accounts is the GA account balance of \$907,447. Costs for the commodity portion of electricity service reflects the sum of two charges: the price of electricity established by the operation of the Independent Electricity System Operator (IESO) administered wholesale market, and the GA.<sup>10</sup>

The GA is paid by consumers in several different ways:

- For RPP customers, the GA is incorporated into the standard commodity rates, therefore there is no variance account for the GA.
- Customers who participate in the Ontario Industrial Conservation Initiative
  program are referred to as "Class A" customers. These customers are assessed
  GA costs through a peak demand factor that is based on the percentage their
  demand contributes to the top five Ontario system peaks. This factor determines
  a Class A customer's allocation for a year-long billing period that starts in July
  every year. As distributors settle with Class A customers based on the actual GA
  costs there is no resulting variance.
- "Class B" non-RPP customers pay the GA charge based on the amount of electricity they consume in a month (kWh). Class B non-RPP customers are billed GA based on an IESO published GA price. For Class B non-RPP customers, distributors track any difference between the billed amounts and actual costs in the GA Variance Account for disposal, once audited.

Under the general principle of cost causality, customer groups that cause variances should be responsible for paying (or receiving credits) for their disposal. The movement

from one class to another should not prevent identifiable customers from paying down/receiving a debit/credit balance.

ENWIN Utilities proposes the recovery of its GA variance account balance of \$907,447 as at December 31, 2017, including interest to April 30, 2019, in accordance with the following table:

The balance of the Group 1 accounts includes a credit of \$15,208 for the refund of Capacity Based Recovery (CBR) charges for Class B customers related to the IESO's wholesale energy market for Capacity Based Recovery program. Distributors pay CBR charges to the IESO and record these to a dedicated sub-account. The disposition of this sub-account is impacted by whether or not a distributor had any customers who were part of Class A during the period from January 2017 to December 2017. The disposition is also impacted by whether or not the Class B CBR rate riders in the 2019 IRM Rate Generator Model<sup>12</sup> rounds to zero at the fourth decimal place in one or more rate classes.

ENWIN Utilities had Class A customers during the period from January 2017 to December 2017 but the CBR Class B rate riders calculated rounded to zero at the fourth decimal place in one or more of the rate classes. In this event, the entire Account 1580 sub-account CBR Class B is added to the Account 1580 WMS control account to be disposed through the general purpose Group 1 Deferral and Variance Account.

The remaining Group 1 accounts being sought for disposition, through the general Deferral and Variance Account rate rider, include the following flow through variance accounts: Smart Meter Entity Charges, Wholesale Market Service Charges, Retail Transmission Service Charges, and Commodity Power Charges. These Group 1

accounts have a total credit balance of \$1,619,836, which results in a refund to customers.

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.<sup>13</sup>

Last year, the OEB suspended its approvals of Group 1 rate riders on a final basis. As stated in its letter to the sector dated July 20, 2018, the OEB will determine whether the riders will be approved on an interim basis or not approved at all (i.e. no disposition of account balances) on a case by case basis until further notice.<sup>14</sup>

## **Findings**

The OEB approves the disposition of a credit balance of \$712,389 as of December 31, 2017, including interest projected to April 30, 2019 for Group 1 accounts on an interim basis. As noted earlier, the OEB's Filing Requirements allow distributors to propose dispositon in cases where the threshold is not triggered. The OEB approves the eight month dispositon period in order to align with ENWIN Utilities' intent to request an effective date of January 1, 2020 in its upcoming cost-based rate application. ENWIN Utilities' analysis shows no signficant potential for spikes in total bill impacts for either RPP and non-RPP customers.

The following table identifies the principal and interest amounts which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*. The date of the transfer must be the same as the effective date for the associated rates, which is, generally, the start of the rate year. ENWIN Utilities shall ensure these adjustments are included in the reporting period ending June 30, 2019 (Quarter 2).

The OEB approves these balances to be disposed through interim rate riders, and charges as calculated in the Rate Generator Model. The interim rate riders, and charges will be in effect over an eight-month period from May 1, 2019 to December 31, 2019.<sup>16</sup>

## 8 RESIDENTIAL RATE DESIGN

All residential distribution rates currently include a fixed monthly charge and a variable usage charge. The OEB's residential rate design policy stipulates that distributors will transition residential customers to a fully fixed monthly distribution service charge over a four-year period, beginning in 2016.<sup>17</sup> This is the last year of ENWIN Utilities' transition period and, accordingly, 2019 is the final year in which ENWIN Utilities' rates will be

adjusted upwards by more than the mechanistic adjustment alone. ENWIN Utilities has transitioned to a fully fixed structure.

The OEB expects an applicant to apply two tests to evaluate whether mitigation of bill impacts for customers is required during the transition period. Mitigation usually takes the form of a lengthening of the transition period. The first test is to calculate the change in the monthly fixed charge, and to consider mitigation if it exceeds \$4. The second is to calculate the total bill impact of the proposals in the application for low volume residential customers (defined as those residential RPP customers whose consumption is at the 10<sup>th</sup> percentile for the class). Mitigation may be required if the bill impact related to the application exceeds 10% for these customers.

ENWIN Utilities notes that the implementation of the transition results in an increase to the fixed charge prior to the price cap adjustment of \$3.71. The bill impacts arising from the proposals in this application, including the fixed rate change, are below 10% for low volume residential customers.

## **Findings**

The distributor has now completed its transition to a fully fixed rate structure.

The OEB finds that the proposed 2019 increase to the monthly fixed charge is calculated in accordance with the OEB's residential rate design policy. The results of the monthly fixed charge, and total bill impact for low consumption residential consumers demonstrate that no mitigation is required. The OEB approves the increase as proposed by the applicant and calculated in the final Rate Generator Model.

## 9 IMPLEMENTATION AND ORDER

This Decision is accompanied by a Rate Generator Model, applicable supporting models, and a Tariff of Rates and Charges (Schedule A).

Model entries were reviewed in order to ensure that they are in accordance with ENWIN Utilities' last cost of service decision, and to ensure that the 2018 OEB-approved Tariff of Rates and Charges, as well as the cost, revenue and consumption results from 2017, are as reported by ENWIN Utilities to the OEB.

The Rate Generator Model was adjusted, where applicable, to correct any discrepancies. The Rate Generator Model incorporates the rates set out in the following table.

Each of these rates is a component of the "Regulatory Charge" on a customer's bill, established annually by the OEB through a separate, generic order. The RRRP, WMS and CBR rates were set by the OEB on December 20, 2018.<sup>18</sup>

The Smart Metering Entity Charge is a component of the "Distribution Charge" on a customer's bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set by the OEB on March 1, 2018.<sup>19</sup>

### THE ONTARIO ENERGY BOARD ORDERS THAT

The Tariff of Rates and Charges set out in Schedule A of this Decision and Rate
Order is approved effective May 1, 2019 for electricity consumed or estimated to
have been consumed on and after such date. ENWIN Utilities Ltd. shall notify its
customers of the rate changes no later than the delivery of the first bill, reflecting the
new final and interim rates.

### RESIDENTIAL SERVICE CLASSIFICATION

A customer qualifies for residential rate classification if their service is a 120/240 V single-phase supply to a single family dwelling, duplex, triplex, 4-plex or 6-plex, townhome or multi-unit - individually metered apartment, located on a parcel of land zoned by the City of Windsor Building Department for domestic or household purposes and where the customer uses the dwelling as a home. Where a customer operates an advertised business from a building that may or may not be used as a dwelling, EnWin Utilities Ltd. may elect to deem that the customer's rate class will be General Service. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

#### **APPLICATION**

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES - Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale participant.

It should be noted that this schedule does not list any charges, assessments, or credits that are required by law to be invoiced by a distributor and that are not subject to Ontario Energy Board approval, such as the Global Adjustment and the HST.
