**Re: OEB File No. EB-2018-0165 Toronto Hydro-Electric System Limited ("Toronto Hydro")
Custom Incentive Rate-setting ("Custom IR") Application for 2020-2024 Electricity Distribution
Rates and Charges – Toronto Hydro Interrogatories on Expert Evidence**

On March 20, 2019, the Distributed Resource Coalition ("DRC") filed a report prepared by the Canadian Urban Transit Research & Innovation Consortium ("CUTRIC"). Toronto Hydro confirms that it is not going to file interrogatories on CUTRIC's evidence.

On March 20, 2019, Board Staff filed a report prepared by Pacific Economics Group Research LLC ("PEG"). On March 26, 2019, Board Staff made available to Toronto Hydro the confidential PEG Working Papers that were used in the preparation of the report ["PEG's Evidence"].

Toronto Hydro requests an extension of ten (10) days to submit interrogatories on PEG's evidence because it needs more time to analyze PEG's Working Papers in order to reflect this analysis in its interrogatories. Toronto Hydro also proposes that the same extension be granted for the filing of responses to Toronto Hydro's interrogatories. The requested extensions can be summarized as follows:

1. Toronto Hydro shall file its interrogatories on PEG's evidence with the OEB and serve copies on all parties by **April 8, 2019**.
2. OEB staff shall file with the OEB complete written responses to the interrogatories on PEG's evidence and serve them on Toronto Hydro and all intervenors by **April 22, 2019**.

Toronto Hydro submits the proposed extensions would not impact any of the steps set out in the OEB's Procedural Order No. 4 and No. 5, and therefore that the OEB should grant this request.
