Further to the Ontario Energy Board's (the "**Board**") directions in Procedural Order No. 8 dated January 8, 2019, please find enclosed draft Certificates of Public Convenience and Necessity (each a "**Certificate**"), with accompanying service area maps, for the following municipalities:

- Norfolk County
- Municipality of Bayham (County of Elgin)
- Municipality of Central Elgin (County of Elgin)
- Township of Malahide (County of Elgin)
- Municipality of Thames Centre (County of Middlesex)

To assist in confirming the accuracy of the included and excluded areas of each Certificate, we have included footnotes with source information details in the draft Certificates. We anticipate that these footnotes would be removed once the Certificates are confirmed as final and complete.

Finally, in preparing these draft Certificates and the accompanying maps, EPCOR has observed that substantial portions of E.B.C. 111 and 119 dated October 15, 1981 (the "Omnibus CPCN") have been superseded, leaving only the Town of Aylmer and certain areas within the Township of South-West Oxford and the former Township of Westminister (now part of the City of London) as being covered by the Omnibus CPCN. If the Board is amenable, EPCOR would be pleased to submit draft Certificates and maps for these areas so that the Omnibus CPCN can be cancelled in its entirety. Subject to guidance from the Board, EPCOR anticipates being able to provide such draft Certificates and maps by April 18, 2019.







Norfolk Township Service Map, Norfolk County












Municipality of Bayham Service Map, Elgin County












Municipality of Central Elgin Service Map, Elgin County












Township of Malahide Service Map, Elgin County
