# ONTARIO ENERGY BOARD NOTICE

A COMMISSIONER, ETC.

Enbridge Gas Inc. has applied to the Ontario Energy Board for approval to construct approximately 13.5 kilometres of natural gas pipelines in the Municipality of Chatham-Kent.

### Learn more. Have your say.

If approved, the proposed project would involve the construction of a 500-metre natural gas pipeline (Bear Line Section) and a 13-kilometre natural gas pipeline (Base Line Section) in the Municipality of Chatham-Kent. Enbridge Gas Inc. says the project is needed to serve potential growth and identified customer demand within the Municipality of Chatham-Kent.

Enbridge Gas Inc. is also asking the Ontario Energy Board to approve the form of agreement it offers to landowners to use their land for routing or construction of the proposed pipeline.

The proposed pipelines are identified in the maps.

### THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Enbridge Gas. During the hearing, we will question Enbridge Gas on the case. We will also hear questions and arguments from individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas' compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

The OEB advises Indigenous communities that the OEB's process for this application may serve as a component of the Crown's duty to consult for this project.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

You have the right to information regarding this application and to be involved in the process. • You can review the application filed by Enbridge Gas on the OEB's website now.

- You can file a letter with your comments, which will be considered during the hearing.


#### **ORAL VS. WRITTEN HEARINGS**



Enbridge Gas Inc. a déposé une requête auprès de la Commission de l'énergie de l'Ontario en vue d'obtenir l'autorisation de construire des gazoducs d'environ 13,5 kilomètres au total dans la municipalité de Chatham-Kent.




