 - ii. The band councils of all Indigenous communities and First Nation Reserves to which EPCOR Natural Gas supplies gas
 - iii. The Métis Nation of Ontario
 - iv. Intervenors in EPCOR Natural Gas' 2018 Cap-and-Trade Compliance Plan proceeding EB-2017-0275
 - v. Intervenors in EPCOR Natural Gas' rate proceeding EB-

2018-0336

- vi. The Ontario Ministry of Energy, Northern Development and Mines
 - vii. The Ontario Ministry of the Environment, Conservation and Parks
 - viii. Environment and Climate Change Canada
 - ix. Enbridge Gas Inc.
2. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at EPCOR Natural Gas' office and in a prominent place on EPCOR Natural Gas' website.
 3. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 2 above immediately thereafter.
 4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
